**RE: APPROVAL OF PUBLIC PARTICIPATION PLAN FOR LA CROSSE COUNTY COMPREHENSIVE PLAN**

**WHEREAS**, La Crosse County has decided to prepare a County Development Plan pursuant to ss. 59.69(2) and (3), Wis. Stats.; and,

**WHEREAS**, section 66.1001(4)(a), Wis. Stats., requires that the governing body of the local governmental unit shall adopt written procedures that are designed to foster public participation in every stage of the preparation of a comprehensive plan, which procedures shall also provide for wide distribution of elements of the comprehensive plan and opportunity for written comments on the development plan to be submitted by the public; and,

**WHEREAS**, the Planning, Resources and Development Committee is designated as the La Crosse County Zoning Agency for the purposes defined in s. 59.69(3)(a), Wis. Stats., for the duration of the comprehensive planning process; and,

**WHEREAS**, La Crosse County has selected the consultant firm of Schreiber/Anderson Associates, Inc., by Resolution #17-05/05 to assist La Crosse County in preparation of the La Crosse County Comprehensive Plan; and,

**WHEREAS**, the agreement between La Crosse County and Schreiber/Anderson Associates, Inc., will include written procedures to foster public participation as required by Wisconsin law; and,

**WHEREAS**, the Planning, Resources and Development Committee has reviewed the "Public Participation Plan for the La Crosse County Comprehensive Plan Process" and believes the adoption of said Plan is in the best interest of La Crosse County to help insure that the Comprehensive Plan meets the wishes and expectations of the public.

**NOW THEREFORE BE IT RESOLVED**, that the La Crosse County Board does hereby approve the written procedures included in the "Public Participation Plan for the La Crosse County Comprehensive Plan Process" as its public participation procedures meeting the requirements of s. 66.1001(4)(a), Wis. Stats.
