**The Specialized Transportation Assistance Grant Application for 2012 is scheduled for a public hearing on Tuesday, December 6, 2011 at 11:15 a.m. in the dining room at Carroll Heights, 3505 Park Lane Drive, La Crosse, Wisconsin.**

**The Public Hearing will be held for the purpose of receiving comment for La Crosse County's proposed plan for spending the allocation of \$250,175 authorized under Section s85.21 of the Wisconsin Statutes to implement an elderly and disabled transportation program. La Crosse County will provide matching funds of at least 20% of the state grant, \$50,035. This program funds the Mini Bus, Volunteer Driver Program, Find A Ride, a mobility manager and a program for those needing additional assistance with their transportation. At the hearing, there will be an opportunity for all persons or agencies interested in the grant application to submit written or oral comments and recommendations.**
