RE: ACCEPTANCE OF BID FOR SHINGLE AND WOOD WASTE PROCESSING CONTRACT B-08

WHEREAS, La Crosse County Solid Waste Department solicited bids for shingle and wood waste processing for a period of two and one-half years from July 1, 2008 through December 31, 2010; and,

WHEREAS, the bidders were required to bid on the landfill operations and maintenance with the option of bidding separately for the wood waste and shingle processing work or bidding on the shingle and wood waste processing work only if receiving the bid for the landfill operations; and,

WHEREAS, the bids were publicly opened on January 12, 2008; and,

NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board hereby authorizes awarding the contract for shingle and wood waste processing to St. Joseph Construction Company, Inc. of La Crosse, Wisconsin in accordance with the bid opened on January 12, 2008 and the contract specifications provided by La Crosse County; and,

BE IT FURTHER RESOLVED, that the County Board Chair and County Clerk are hereby authorized to execute any agreements to accomplish said work, after approval by Corporation Counsel.
