**RE: ACCEPTANCE OF BID FOR LANDFILL OPERATIONS CONTRACT A-08**

WHEREAS, La Crosse County Solid Waste Department solicited bids for landfill operations and maintenance for a period of six and one-half years from July 1, 2008 through December 31, 2014, with an option for two additional two-year extensions; and,

WHEREAS, the bidders were required to bid on the landfill operations and maintenance with the option of bidding separately for the wood waste and shingle processing work or bidding on the shingle and wood waste processing work only if receiving the bid for the landfill operations; and,

WHEREAS, the bids were publicly opened on January 12, 2008; and,

WHEREAS, the lowest, most responsive bid for the landfill operations and maintenance work was submitted by St. Joseph Construction Company, Inc. of La Crosse, Wisconsin, for an estimated total sum of \$687,500 for the first year of such work, based upon the price per ton of figures submitted.

NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board hereby authorizes awarding the contract for landfill operations and maintenance to St. Joseph Construction Company, Inc. of La Crosse, Wisconsin in accordance with the bid opened on January 12, 2008 and the contract specifications provided by La Crosse County; and,

BE IT FURTHER RESOLVED, that the County Board Chair and County Clerk are hereby authorized to execute any agreements to accomplish said work, after approval by Corporation Counsel.

FISCAL NOTE: Funds provided in the 2008 Solid Waste Site Operations, Org. 6500, Account 64082. Funds will need to be budgeted for future contract years.
