The County Board of Supervisors of La Crosse County does ordain as follows:

AN ORDINANCE TO AMEND S. 4.02(4) ENTITLED "CHARGES FOR IN REM FORECLOSURES UNDER S. 75.521, WIS. STATS." OF THE GENERAL CODE OF LA CROSSE COUNTY, WISCONSIN

ANALYSIS

The purpose of this amendment is to provide that the County Board shall periodically determine the costs to be assessed to owners of parcels subject to tax foreclosure actions instead of specifying the cost amount in the ordinance.

INFORMATION:

County Board Rules: Governing Body s. 2.02(8) states, in part: Ordinances are drafted by the Corporation Counsel. After the ordinance has been reviewed by a standing committee, each Supervisor will be given a copy of the ordinance showing the deleted language (grayed) and the new language (underlined) and an analysis of the intent of the ordinance. After introduction to the County Board, the ordinance shall be referred to the next monthly meeting unless waived by a 2/3 vote of the Supervisors present and a public hearing may be held if requested by a Supervisor. An amendment may be introduced and debated at either the original or the referred meeting. ORDINANCE #69 - 11/08

AN ORDINANCE TO AMEND S. 4.02(4) ENTITLED "CHARGES FOR IN REM FORECLOSURES UNDER S. 75.521, WIS. STATS." OF THE GENERAL CODE OF LA CROSSE COUNTY, WISCONSIN

The County Board of Supervisors of the County of La Crosse does ordain as follows:

Section 1. Section 4.02(4) is amended to read:

4.02(4) CHARGES FOR IN REM FORECLOSURES UNDER SECTION 75.521, WIS. STATS. In all cases where the County elects to enforce tax liens pursuant to s. 75.521, Wis. Stats., or any amendments thereto, a charge for the fees and costs incurred by the County in foreclosing the tax lien shall be determined by the County Board and shall be subject to change from time to time.

Section 2. This Ordinance shall take effect the day after passage and publication.
