RE: AUTHORIZING THE APPROVAL OF INCREASES TO CERTAIN LA CROSSE COUNTY PERMITS, FEES, AND CHARGES FOR 2009

WHEREAS, the 2009 budget includes certain fee increases for various revenue accounts commencing January 1, 2009 for various departments; and,

WHEREAS, the fees in each of the departments have been identified in the 10-06-08 and 10-29-08 budget documents entitled "Proposed User Fees, Charges for Services, and Permit Revenue for 2009 Comprehensive Master List"; and,

WHEREAS, the La Crosse County Financial Management Policies indicate that the County will establish service fees and charges wherever appropriate for the purpose of keeping property taxes to a minimum; and ,

WHEREAS, these fees and charges will attempt to fairly allocate the full cost of services to the users of those services whenever possible and as deemed appropriate by the County Board, including consideration of waiving or offering reduced fees to youth, seniors or other special population groups identified as requiring preferential consideration based on policy goals.

NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board does hereby approve budget documents entitled "Proposed User Fees, Charges for Services, and Permit Revenue for 2009 Comprehensive Master List" to be effective commencing January 1, 2009.
