RE: AUTHORIZATION TO APPROVE CHANGE ORDERS

WHEREAS, the La Crosse County LEC Addition and Remodeling project includes base bid constructions costs of \$21,052,543; and,

WHEREAS, 5% of base bids construction costs is considered to be a reasonable estimate for addressing changes to construction plans and problems that will normally occur in a project of this magnitude.

NOW THEREFORE BE IT RESOLVED, that a contingency budget of \$1,052,627 is hereby established for the purpose of addressing changes and problems.

BE IT FURTHER RESOLVED, that change orders up to \$20,000 shall be approved in accordance with existing authority limits set forth in Chapter 4.11 Purchasing Procedures of the Finance Section of the County Ordinance.

BE IT FURTHER RESOLVED, the County Administrator, County Board Chair, and the Sheriff are hereby authorized to jointly approve change orders in amounts greater than \$20,000 but less than \$75,000 upon unanimous agreement.

BE IT FURTHER RESOLVED, that change orders in excess of \$20,000 not receiving unanimous agreement and all change orders in excess of \$75,000 shall require approval of the LEC Construction Committee.

BE IT FURTHER RESOLVED, that a list of all approved change orders shall be provided to the LEC Construction Committee on a monthly basis.

FISCAL NOTE: Contingency amounts are calculated on the based bid construction costs. Base bid of \$21,052,543 times 5% = \$1,052,627.
