Reason for terminating - the Thurston's have sold their home to his parents and moved to Richland County.

The permit was non-transferable.

Stats. and s. 17.36 Zoning Code: the Committee did publish and receive proof of a Class II notice of the hearing; did receive receipts of mailing of the notices to the affected Town Clerk(s); did hold a public hearing to hear testimony or correspondence from the people; and, did receive and consider action from the affected Town Board(s). The Committee and the affected Town Board(s), under s. 17.36(4), have the authority to approve the application with integral conditions or to disapprove of the application. Having considered the entire record the Committee's recommendation is to: **Terminate**

By a vote of 5 in favor, 2 excused - Meyer and Rauk, the Committee recommended approval to terminate Conditional Use Permit No. 686 because the parcel had been transferred to his parents and use had been discontinued for a period in excess of 12 consecutive months.

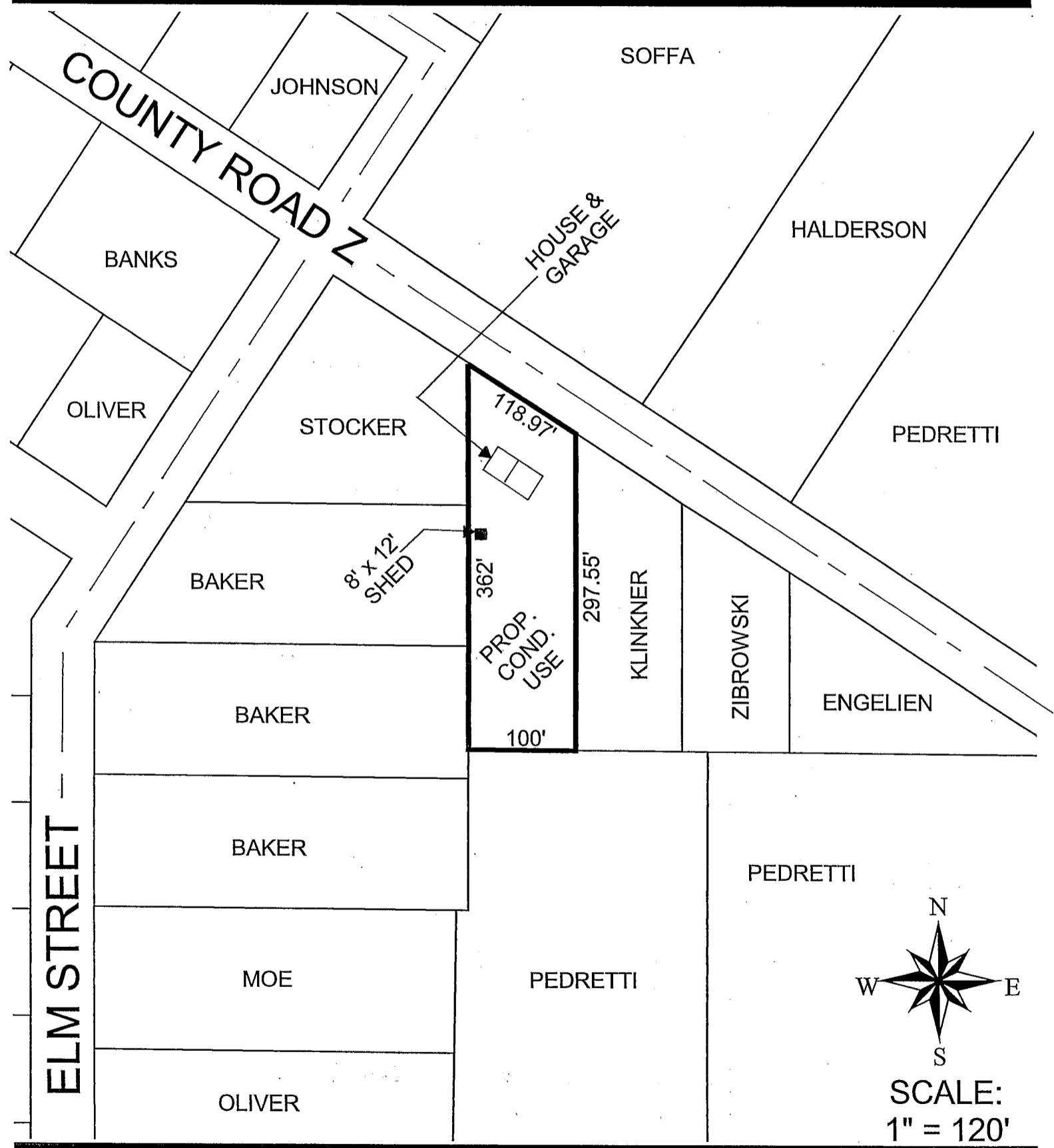
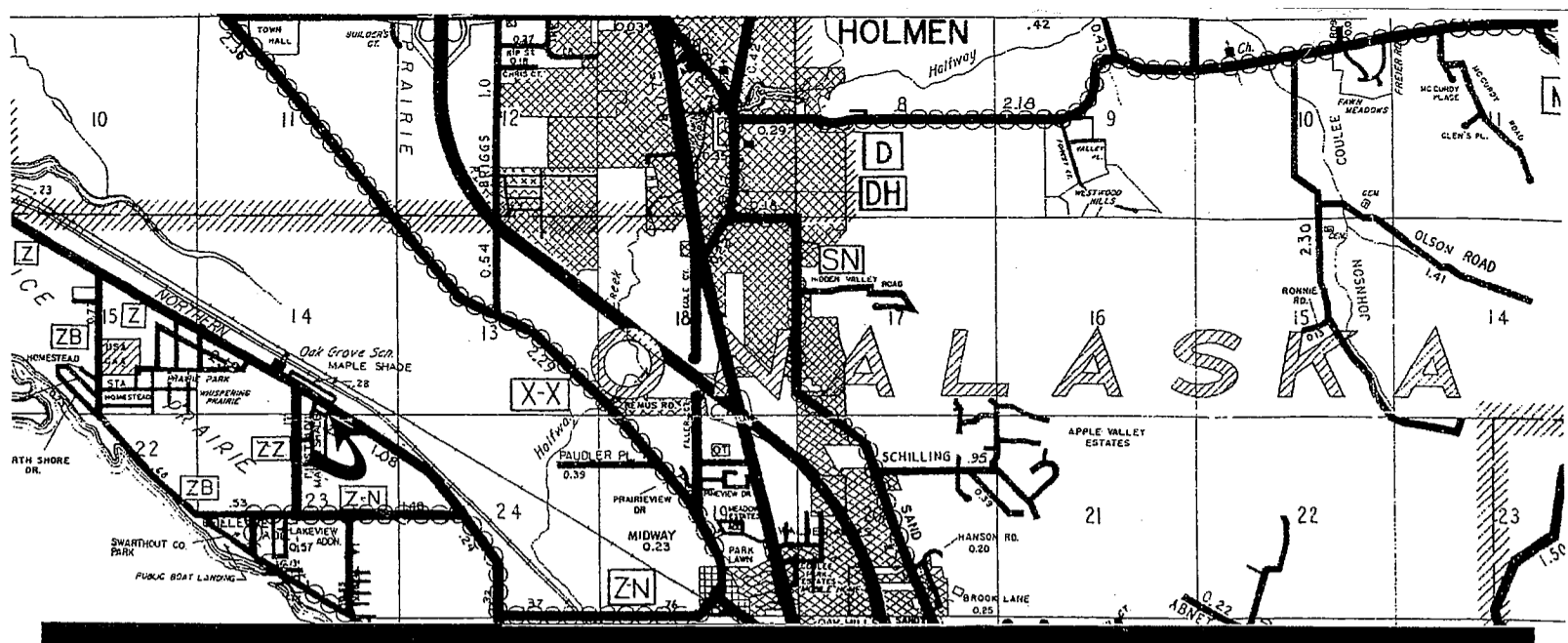
