

REPORT OF THE PLANNING, RESOURCES AND DEVELOPMENT COMMITTEE  
TO THE COUNTY BOARD ON A HEARING FOR A CONDITIONAL USE PERMIT

TO THE COUNTY BOARD OF SUPERVISORS OF LA CROSSE COUNTY:

The La Crosse County Planning, Resources and Development Committee, having considered the application filed by:

TODD WRIGHT W7089 GAARDER RD HOLMEN WI 54636, O/B/O  
DONALD C. & KAREN R. HEIDEL REVOCABLE TRUST W5779 MAHLUM RD HOLMEN WI 54636

and having held a public hearing on the 28th day of APRIL 2008 for a Conditional Use Permit to amend existing Conditional Use Permit No. 700 condition #5 to amend the final removal date of the stockpile from December 31, 2007 to December 31, 2008

on land that is zoned EXCLUSIVE AGRICULTURAL DISTRICT in the TOWN of FARMINGTON

**ON LAND DESCRIBED AS:** The SE-SE of Section 15, T 18 N, R 7 W. Town of Farmington.

And pursuant to s. 59.69 Wis. Stats. and s. 17.36 Zoning Code: the Committee did publish and receive proof of a Class II notice of the hearing; did receive receipts of mailing of the notices to the affected Town Clerk(s); did hold a public hearing to hear testimony or correspondence from the people; and, did receive and consider action from the affected Town Board(s). The Committee and the affected Town Board(s), under s. 17.36(4), have the authority to approve the application with integral conditions or to disapprove of the application. Having considered the entire record the Committee's recommendation is to: **Approve subject to 5 conditions.**

By a vote of 5 in favor (Meyer excused, Pedretti abstained) the Committee recommended approval of the permit by replacing Conditional Use Permit No. 700 in its entirety and replacing it with one subject to all 5 of the original conditions and amending condition number 5 as follows:

1. Permit granted to allow excess borrow materials excavated from farm pond to be removed from farm site along the edge of public road.
2. There will be no tracking on public roads. If so, the hauler is required to scrape and clean up at the end of the day.
3. An approved erosion control plan is required until the stockpiles are completely removed.
4. This permit allows for the removal of the 5,300 cubic yards already stockpiled.
5. This permit expires December 31, 2008 at which time all reclamation shall be finished.

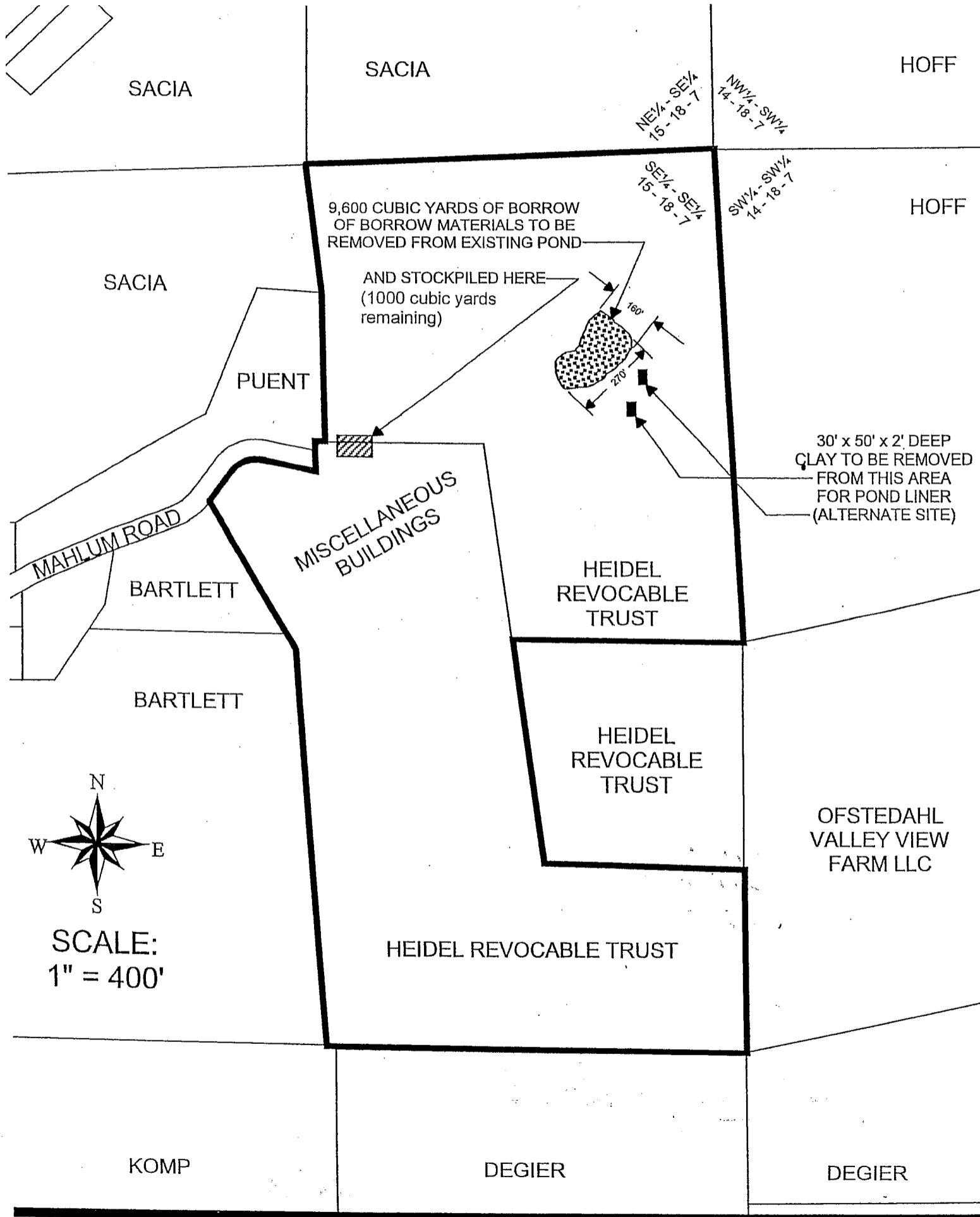
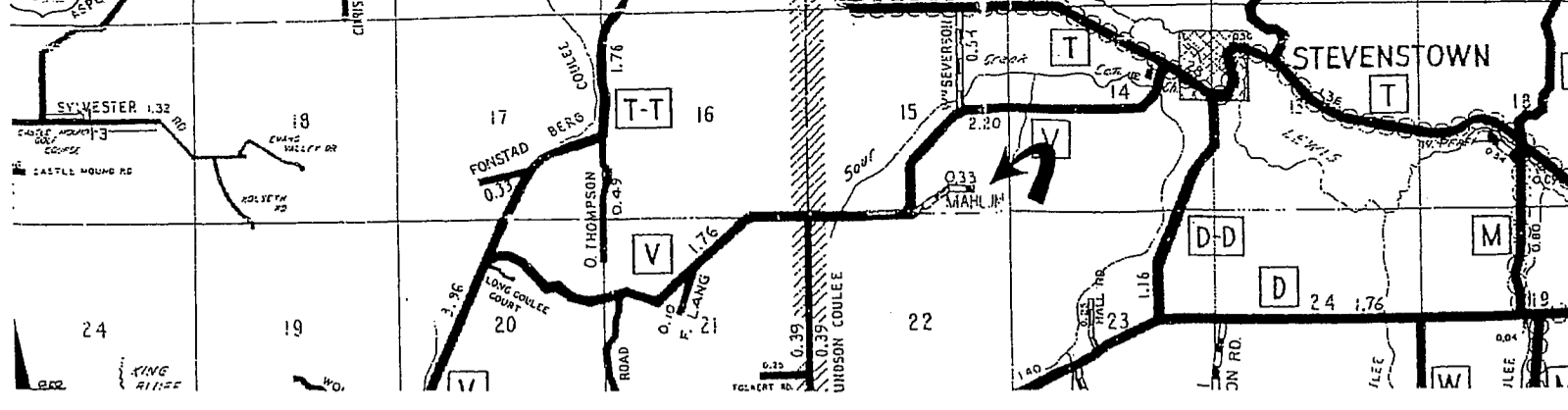
