**RE: AUTHORIZATION TO INCREASE PART-TIME HOURS AND PROVIDE FUNDING FOR A CLERK ENTRY POSITION IN THE VETERANS SERVICE OFFICER DEPARTMENT**

WHEREAS, the Veterans Service Officer Department has experienced a significant increase in the workload that deals with Veteran's burial benefits; and,

WHEREAS, the office has processed cases for 76 County Veteran deaths from January 1 through March 31, 2009; and,

WHEREAS, this represents a 26% increase compared to the first quarter of 2008; and,

WHEREAS, the part-time clerk position that deals with these cases has been vacant for most of the 1<sup>st</sup> quarter; and,

WHEREAS, in order to deal with the extra workload, the Veterans Service Officer is requesting that approval of additional hours be granted.

NOW THEREFORE BE IT RESOLVED, that the Veterans Service Officer be allowed to increase the hours of their clerk entry position to 23 hours per week which would add \$3,500 additional salary and fringe costs.

BE IT FURTHER RESOLVED, that the Finance Department is authorized to transfer \$3,500 from the County's Salary Contingency account to the Salary Account-Clerk Entry Position of the Veterans Service Department.

FISCAL NOTE: The starting hourly wage of a Clerk Entry position is \$13.05 per hour. Increased hours will make this position eligible for part-time insurances.
