RE: INVASIVE DISEASE CARRYING MOSQUITO CONTROL – HEALTH FUND TRANSFER

WHEREAS, Ochlerotatus japonicus, an invasive mosquito vector of La Crosse Virus and West Nile Virus has been found in La Crosse and surrounding counties; and,

WHEREAS, this mosquito species greatly increases the opportunity for human infection with arboviruses; and,

WHEREAS, targeted control of this mosquito species will reduce human exposure to arboviral infection.

NOW THEREFORE BE IT RESOLVED, that \$10,000 be transferred from the La Crosse County Health Fund balance to the 2009 Health Dept. Vector Control budget to be utilized to employ limited term vector control staff for surveillance and control of Oc. japonicus.

BE IT FURTHER RESOLVED, that \$9,319.00 from the 2009 Vector Control Budget that was to be used for non-staff Vector Control activities is requested to be used to add limited term staff time for surveillance and control of Oc. japonicus.

FISCAL NOTE: Increase Vector Control Monitor limited term staff time by .987 FTE at a cost of \$9.41/hr (salary and fringe) resulting in a total cost of \$19,319 for 2009. The additional \$10,000 will be transferred from the Health Fund undesignated fund balance.
