RE: APPROVAL OF BID FOR SANITARY LANDFILL MAINTENANCE GARAGE CONSTRUCTION

WHEREAS, there is a need for the construction of a new maintenance garage at the La Crosse County Sanitary Landfill and La Crosse County is obligated to construct such a garage pursuant to its 2008 operations contract; and,

WHEREAS, La Crosse County has requested bids for the construction of a new maintenance garage, including water supply, waste disposal, and adjacent parking areas; and,

WHEREAS, sealed bids were received and publically opened on July 1, 2009; and,

WHEREAS, said bids had been reviewed for qualification of bidders and costs by the Public Works & Infrastructure Committee; and,

WHEREAS, this project was included in the La Crosse County 2009 Solid Waste Budget.

NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board does hereby approve the bid of Olympic Builders General Contractors, Inc. in the amount of \$601,800.00 for Project B-09 Maintenance Garage Construction, with an additional 5% contingency fee of \$30,090 for a total of \$631,890.

BE IT FURTHER RESOLVED, that the County Board Chair is hereby authorized to execute any agreements to accomplish said work in accordance with the specifications and the bids submitted, after approval by Corporation Counsel.
