### RE: SUPPORT OF FILM AND VIDEO PRODUCTION IN LA CROSSE COUNTY

**WHEREAS**, film and video production industries are encouraged to come to the State of Wisconsin by the passage of Wis. Stat. s. 560.206 which provides for film production tax credits; and,

**WHEREAS**, film and video production in the area can be very significant for the purpose of economic development and promotion of the image of La Crosse County; and,

**WHEREAS**, providing local resources and inducements to film and video production companies is desirable as a means to promote film and video production within La Crosse County and the region of Western Wisconsin; and,

**WHEREAS**, the Film Commission of Western Wisconsin has organized, under the auspices of the Pump House Regional Art Center, Inc. to be a single source of support to location scouts and production houses.

**NOW THEREFORE BE IT RESOLVED**, that the La Crosse County Board does hereby support reasonable accommodation to assist motion picture, video and television production companies.

**BE IT FURTHER RESOLVED**, that the La Crosse County Board may develop appropriate policies and any necessary legislation to support the intent of this resolution.

**BE IT FURTHER RESOLVED**, that a copy of the Resolution will be sent to the La Crosse Area Legislators and the Governor.

**FISCAL NOTE:** this resolution shall not preclude La Crosse County from reaching agreements with film and video production companies to charge for extra county staff or use of equipment or services that they request.
