RE: APPROVE MECHANICAL COMMISSIONING AND WATT METERS FOR AIR HANDLING UNITS FOR LAW ENFORCEMENT ADDITION (LEC)

WHEREAS, the resolution approving the addition to the LEC included a number of energy conservation measures and sustainable design concepts; and,

WHEREAS, the LEC Construction Committee has reviewed all of the sustainable concepts and is recommending that the following items be included for construction of the new addition:

Two watt meters for Air Handling Units	\$3,477
Mechanical Systems Commissioning – Contractor	\$15,000
Mechanical Systems Commissioning Agent – Renschler	<u>\$40,000</u>
TOTAL	\$58,477

NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board hereby approve the above listed items for a total cost of \$58,477.

BE IT FURTHER RESOLVED, that the cost of these items be included in the project funding as determined by the County Board through a combination of the final debt issue or loan from General Fund.

FISCAL NOTE: If this resolution is approved after the resolution on Bio-Retention and Bike Racks, the total project cost to date will be \$30,001,672. This dollar amount includes the original construction bids \$28,946,029; Probation and Parole Build-Out \$641,001; and Alt. Bid E Heat Reclaim \$146,524 which were previously approved by the Board. It also includes the \$150,000 reserve for Solar Hot Water.

Title of Proposal:

Purchase of HVAC Commissioning Services

Background Information:

The objective of this procurement process is to obtain an independent HVAC commissioning contractor.

Seven vendors submitted proposals. Proposals were evaluated by Construction Administrator – River Architects, Project Manager – Potter Lawson, Construction Manager – Market & Johnson, Project Manager – KJWW Engineers, County Facilities Director, and the County Purchasing Manager. Proposals were evaluated on the following criteria:

Evaluation:

The three highest evaluated vendors, based on qualifications and cost, were interviewed by the evaluation team. The summary of evaluations:

Vendor	Evaluation Score	Cost
Renschler	82	\$40,000.00
Arnold O' Sheridan	75	\$30,000.00
Quality Management Services	60	\$29,850.00
JMP	Did not interview	\$66,830.00
PEC	Did not interview	\$68,000.00
Questions & Solutions	Did not interview	\$88,000.00
Michaels	Did not interview	\$88,400.00

Primary strengths of Renschler are:

1. Commission all HVAC equipment, not a percent of total equipment
2. Specializes in commissioning HVAC Systems
3. Organized approach, starting with research and documentation of owner requirements
4. Training of County Facility Department Staff during functional testing
5. Provide ten month follow up for warranty services

Recommendation of Facilities Director:

Based on the evaluation scores, the evaluation team recommends Renschler to provide all HVAC commissioning services through completion of project.

The mechanical contractors need to participate in the commissioning process. This is critical to the long term energy efficiency of the building. The estimated cost of the mechanical contractors participation in the commissioning process is \$25,562.00. Total cost of commissioning is \$65,562.00.
