RE: ADOPTION OF 2010-2012 STRATEGIC PLAN FOR LAKEVIEW HEALTH CENTER

WHEREAS, Lakeview Health Center's Mission Statement provides, in part, a commitment to excellence in providing care and rehabilitation with respect for the dignity and rights of individuals who have special physical, developmental, and mental health needs to residents of La Crosse County and western Wisconsin in cooperation with other health related agencies; and,

WHEREAS, Lakeview Health Center has developed a 3-year Strategic Plan for Lakeview Health Center including interim steps to be completed during 2009, in order to better position the organization for long-term viability; and,

WHEREAS, the Strategic Plan delineates goals and objectives in the following areas: revenue generation, the completion of certain phases of a Remodeling Plan, the development of a management re-organization, regional network development planning, identifying needs of target populations and working with care management organizations to reach agreements on enrollment and reimbursement issues; and,

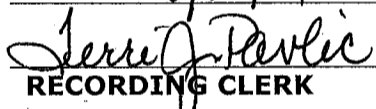
