TO THE COUNTY BOARD OF SUPERVISORS OF LA CROSSE COUNTY:

The La Crosse County Planning, Resources and Development Committee, having considered the application filed by:

and having held a public hearing on the 30th day of November, 2009 on a petition to terminate Conditional Use

Permit No. 274 issued to Henry Johnson, W4511 County Road B; current owners Peter & Christine

Gruendeman, W4511 County Road B, West Salem, WI 54669, and passed by the County Board in June of

1993, to operate a boarding kennel in a new detached accessory building on land zoned AGRICULTURE

DISTRICT "A" in the Town of Barre. Reason for terminating - The business has not operated for the past

12 months (since 2004).


LAND DESCRIBED AS: A parcel of land in the NW-SW Section 17, T16N, R6W; commencing at the Northwest corner of the NW-SW thence S37°27'E, 183.45'; thence S20°56'W, 170.35'; thence S2°43'E, 175.55' thence S5°03'E, 45.4' to POB; thence S47°32'W, 31.65'; thence S42°28'E, 33'; thence S5°03'E 204.35ft; thence N80°09'E, 175.8'; thence N52°30'E 254.3'; thence N19°47'W, 180.75'; thence N31°W, 42.85'; thence N44°08'W, 130.6'; thence S39°39'W, 102.96'; thence S43°55'W, 196.9'; thence S47°32'W 21.52' to POB. Town of Barre.

And pursuant to s. 59.69 Wis. Stats. and s. 17.36 Zoning Code: the Committee did publish and receive proof of a Class II notice of the hearing; did receive receipts of mailing of the notices to the affected Town Clerk(s); did hold a public hearing to hear testimony or correspondence from the people; and, did receive and consider action from the affected Town Board(s). The Committee and the affected Town Board(s), under s. 17.36(4), have the authority to approve the application with integral conditions or to disapprove of the application. Having considered the entire record the Committee's recommendation is to: **Approve termination.**


By unanimous vote, the Committee recommended to terminate Conditional Use Permit No. 274 because the business has not been in operation for over 12 months.



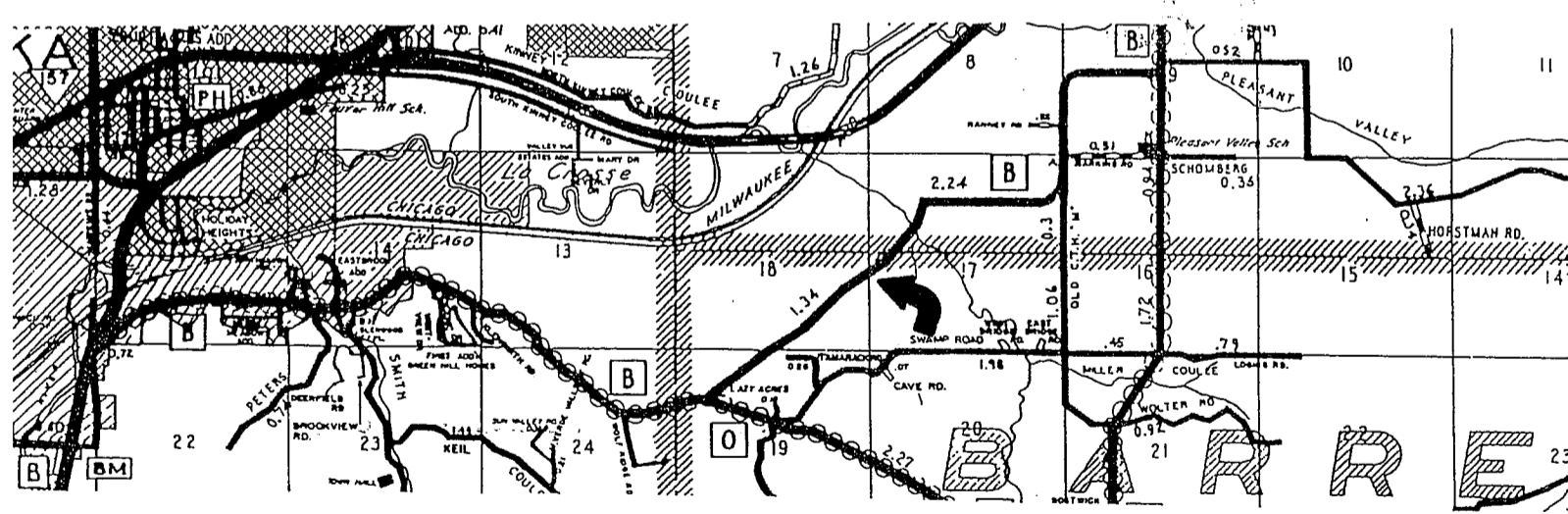
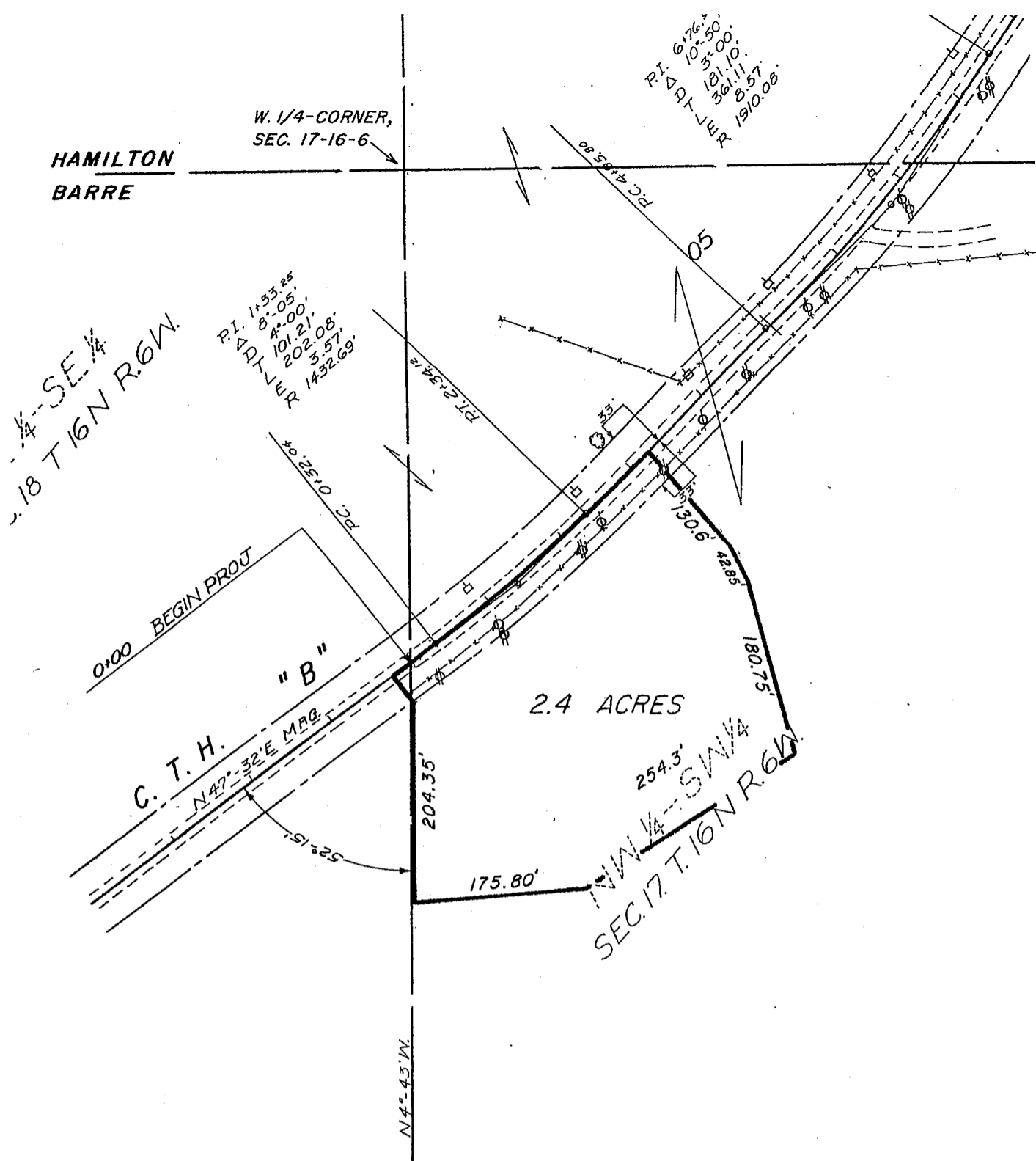
