TO THE COUNTY BOARD ON A HEARING FOR TERMINATION OF A CONDITIONAL USE PERMIT

TO THE COUNTY BOARD OF SUPERVISORS OF LA CROSSE COUNTY:

The La Crosse County Planning, Resources and Development Committee, having considered the application filed by:

and having held a public hearing on the 30th day of November 2009 on a petition to terminate Conditional Use Permit No. 191 issued to John Tomten, Rt 1, Coon Valley, WI; current owners, Duane & Shannon Yachwak, W5129 Quackenbush Rd, West Salem, WI 54669 and passed by the County Board in April of 1990 to operate a boarding kennel on land zoned AGRICULTURE DISTRICT "A" in the Town of Hamilton. Reason for terminating - The business has not operated for the past 12 months (since 2003).


LAND DESCRIBED AS: Part of the SE-NW of Section 25, T17N, R7W described as Beginning 1,027.9' north of the Southeast corner of said forty acre tract, thence North 221'; thence S72°45'W along the center of the road 305.48'; thence S88°43'W 210.5'; thence South 25'; thence S7°45'W 210'; thence N79°32'E 539.49' to the POB. Town of Hamilton.

And pursuant to s. 59.69 Wis. Stats. and s. 17.36 Zoning Code: the Committee did publish and receive proof of a Class II notice of the hearing; did receive receipts of mailing of the notices to the affected Town Clerk(s); did hold a public hearing to hear testimony or correspondence from the people; and, did receive and consider action from the affected Town Board(s). The Committee and the affected Town Board(s), under s. 17.36(4), have the authority to approve the application with integral conditions or to disapprove of the application. Having considered the entire record the Committee's recommendation is to: **Approve termination.**


By unanimous vote, the Committee recommended approval to terminate Conditional Use Permit No. 191 because the business has not operated within the past 12 months.



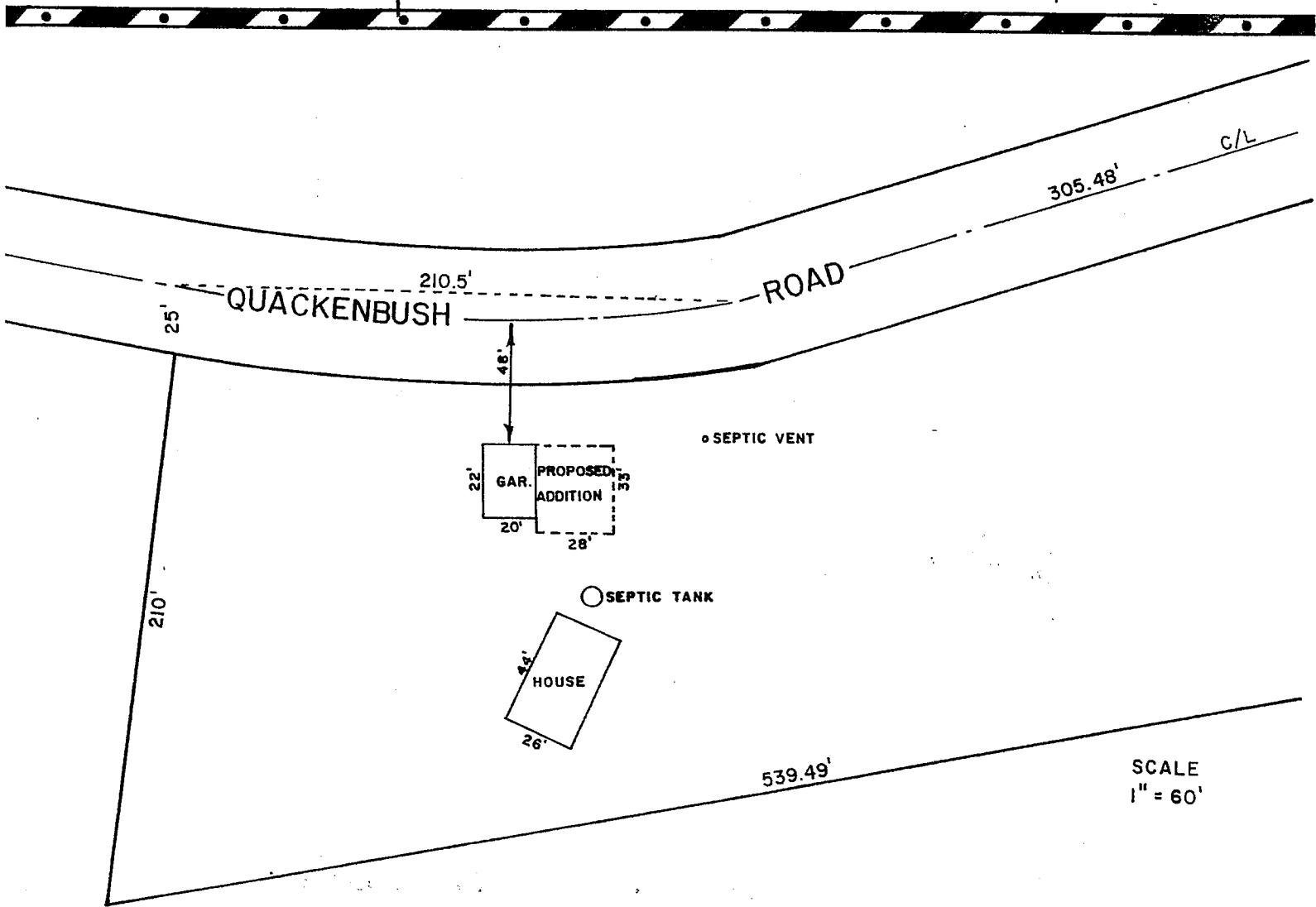
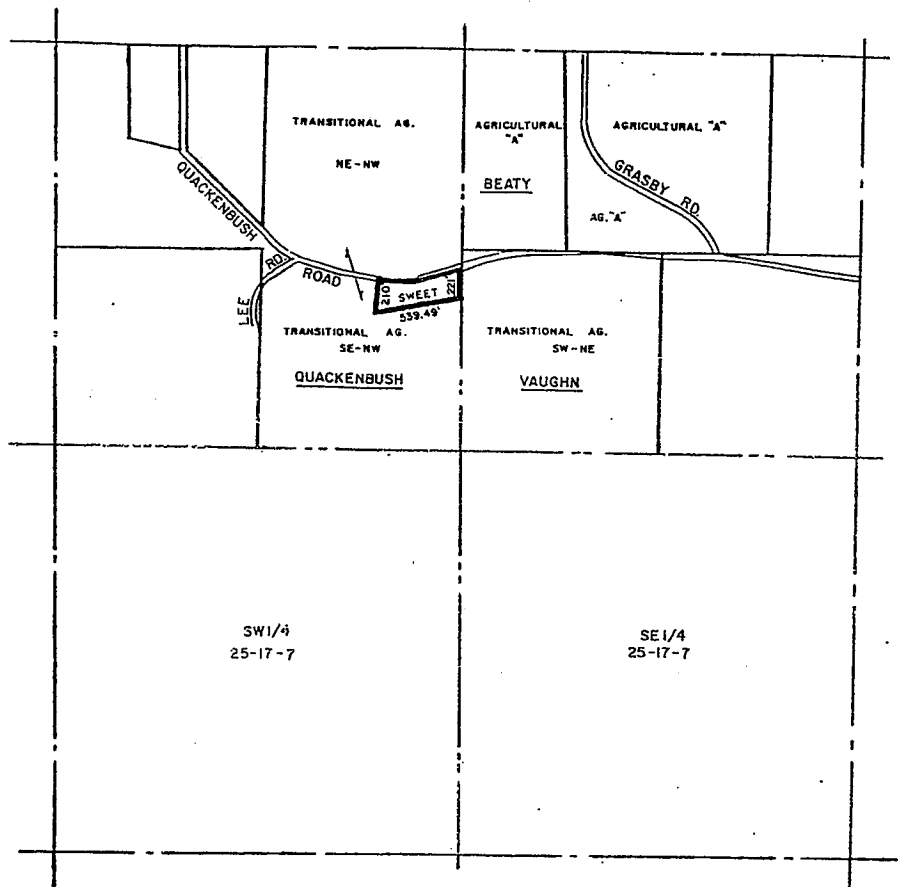
