TO THE COUNTY BOARD OF SUPERVISORS OF LA CROSSE COUNTY:

The La Crosse County Planning, Resources and Development Committee, having considered the application filed by:

and having held a public hearing on the 30<sup>th</sup> day of November 2009 on a petition to terminate Conditional Use Permit No. 350 issued to Greg & Rochelle Gentry, N2366 County Road OA, La Crosse, WI 54601 and passed by the County Board in November of 1995 to operate a fire arms & travel business from their home on land zoned AGRICULTURE DISTRICT "A" in the Town of Greenfield. Reason for terminating - This business has not been in operation since January of 2005.


**LAND DESCRIBED AS:** Part of the SE-NE of Section 5, T15N, R6W Beginning at the NE corner, thence South 656.3', thence West 1272.82'; thence N1°38'W 58'; thence N67°57'E 500.5'; thence N6°30'E 413'; thence East 860' to the POB. Town of Greenfield.

And pursuant to s. 59.69 Wis. Stats. and s. 17.36 Zoning Code: the Committee did publish and receive proof of a Class II notice of the hearing; did receive receipts of mailing of the notices to the affected Town Clerk(s); did hold a public hearing to hear testimony or correspondence from the people; and, did receive and consider action from the affected Town Board(s). The Committee and the affected Town Board(s), under s. 17.36(4), have the authority to approve the application with integral conditions or to disapprove of the application. Having considered the entire record the Committee's recommendation is to: **Approve termination.**


**By unanimous vote, the Committee recommended approval of termination of Conditional Use Permit No. 350 because the business has not been in operation since 2005.**



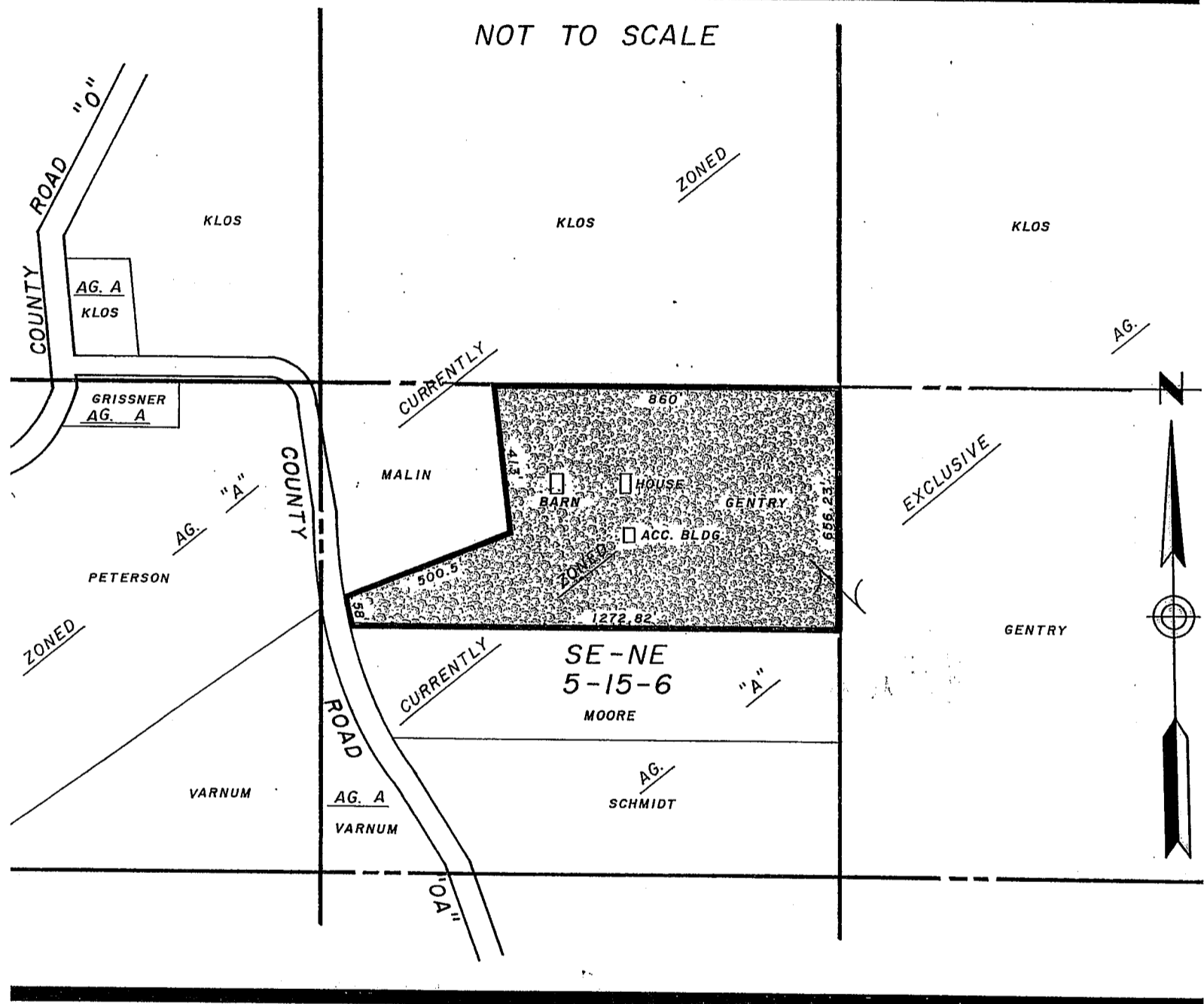
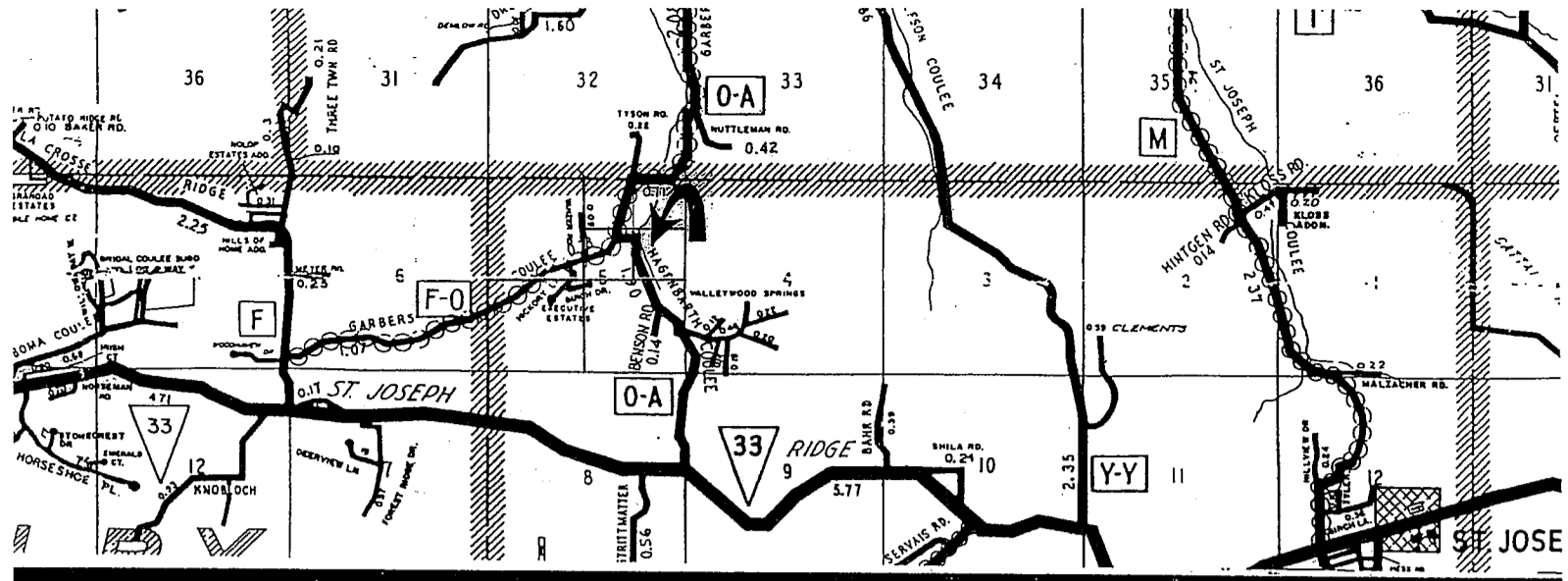
