TO THE COUNTY BOARD OF SUPERVISORS OF LA CROSSE COUNTY:

The La Crosse County Planning, Resources and Development Committee, having considered the application filed by:

and having held a public hearing on the 2nd day of February, 2009 on a petition to terminate Conditional Use

Permit No. 366 issued to Ronald and Kelly McCormick, current owner Kelly Summerfield f/k/a McCormick,

N6057 Filler Ct, Onalaska, WI and passed by the County Board on June 20, 1996 to use a 40' x 60' accessory

Building for contractor's storage in the Town of ONALASKA

Reason for terminating – Business never got started and has not been used for the past 12 consecutive months

LAND DESCRIBED AS: Part of the NE-NW, Section 19, T17N, R7W Beginning 66' north of the North 18 acres, thence West 247.5', thence North 264', thence East 247.5', thence South 264' to the POB. Town of Onalaska.

And pursuant to s. 59.69 Wis. Stats. and s. 17.36 Zoning Code: the Committee did publish and receive proof of a Class II notice of the hearing; did receive receipts of mailing of the notices to the affected Town Clerk(s); did hold a public hearing to hear testimony or correspondence from the people; and, did receive and consider action from the affected Town Board(s). The Committee and the affected Town Board(s), under s. 17.36(4), have the authority to approve the application with integral conditions or to disapprove of the application. Having considered the entire record the Committee's recommendation is to: **Terminate.**

By a vote of 5 in favor, 2 excused – Meyer & Keil, the Committee recommended termination of Conditional Use Permit No. 366.

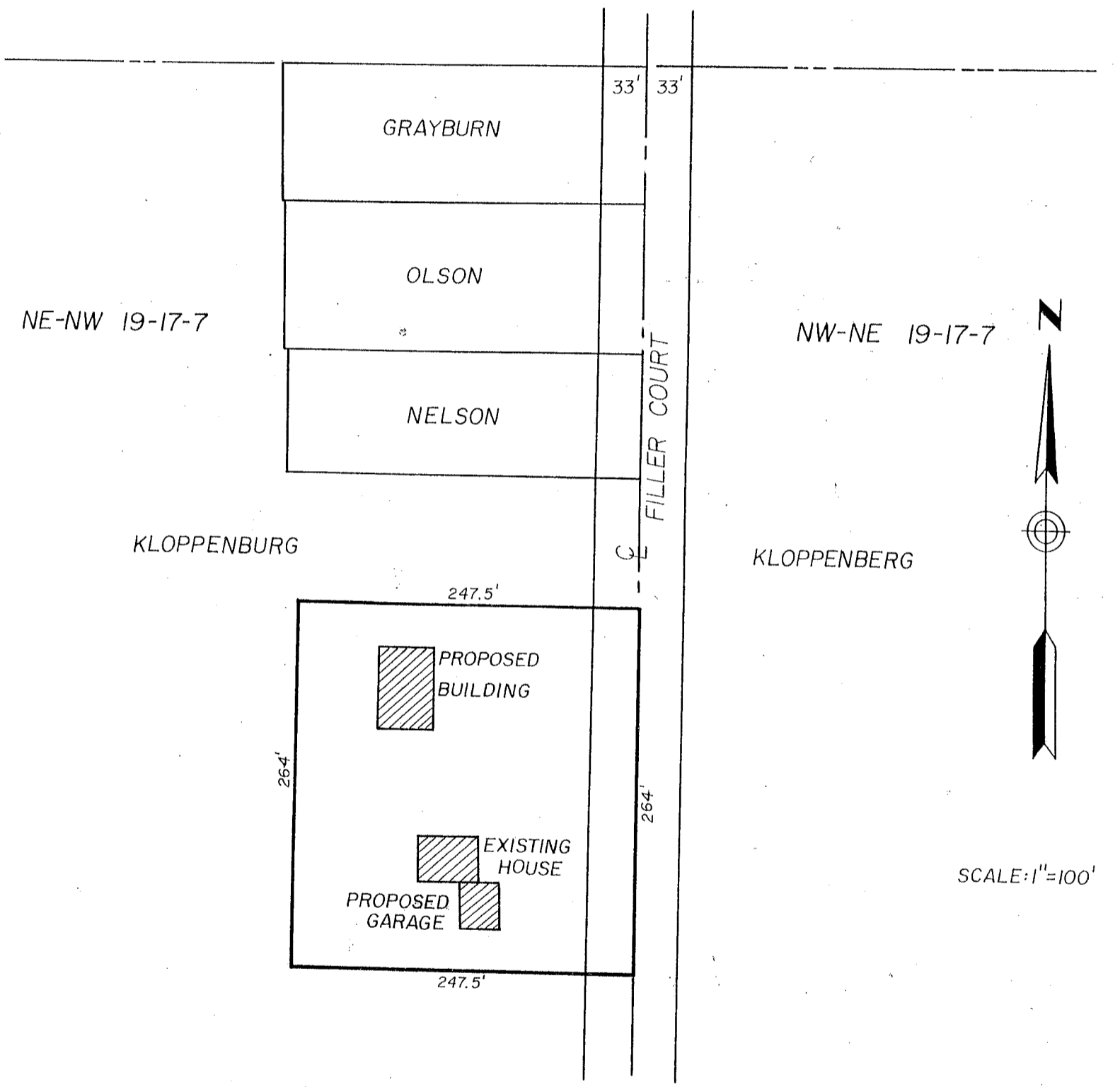
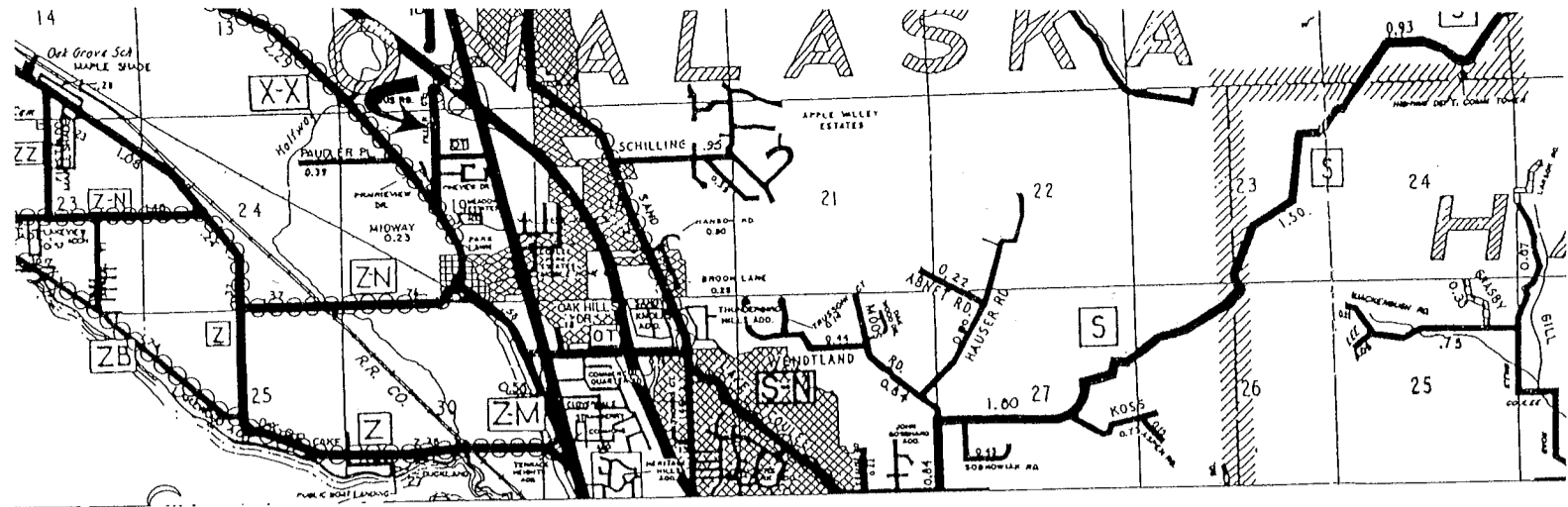
