The La Crosse County Planning, Resources and Development Committee, having considered the application filed by:

and having held a public hearing on the 2nd day of February, 2009 on a petition to terminate Conditional Use Permit No. 72 issued to Mary Craig, current owners Brian and Linda Sing, N3640 Old M Rd, West Salem, WI and Sylvester and Patricia Clements, N3620 Old M Rd, West Salem, WI and passed by the County Board on November 16, 1983 to operate a mower sharpening and repair shop in the Town of BARRE

Reason for terminating – Business has not operated in at least the past 12 consecutive months.

The Committee and the affected Town Board(s), under s. 17.36(4), have the authority to approve the application with integral conditions or to disapprove of the application. Having considered the entire record the Committee's recommendation is to: **Terminate.**


By a vote of 5 in favor, 2 excused – Meyer & Keil, the Committee recommended termination of Conditional Use Permit No. 72.

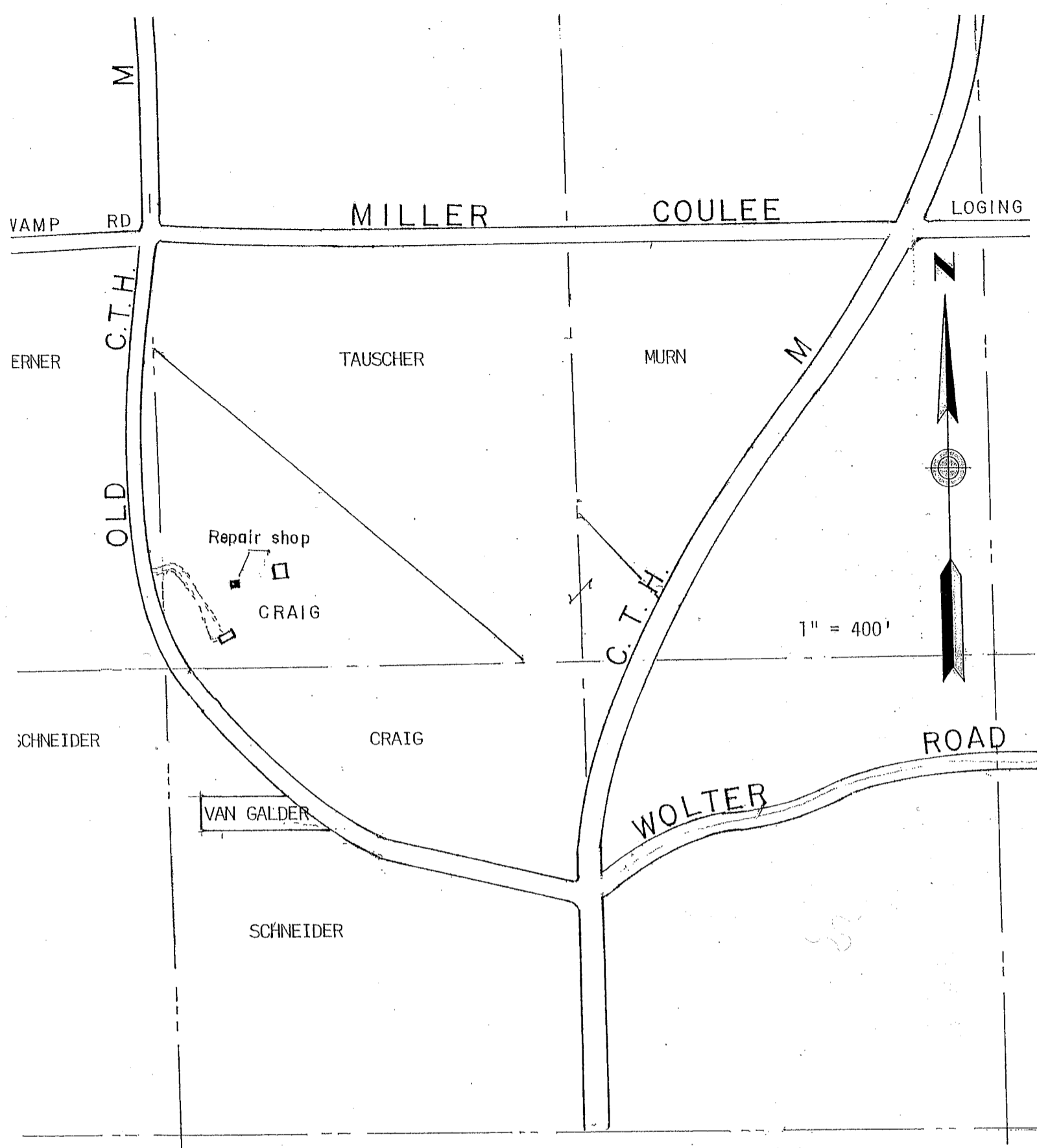
