and having held a public hearing on the 29th day of December, 2008 on a petition to terminate Conditional Use Permit No. 142 issued to Sylvan Holter, current owner Clarence and Sandra Harris, N7304 County Road XX Holmen, WI, and passed by the County Board on May 31, 1988 to keep horses at this address in the Town of HOLLAND
Reason for terminating - the use is no longer utilized and has not been utilized for a period in excess of 12 consecutive months

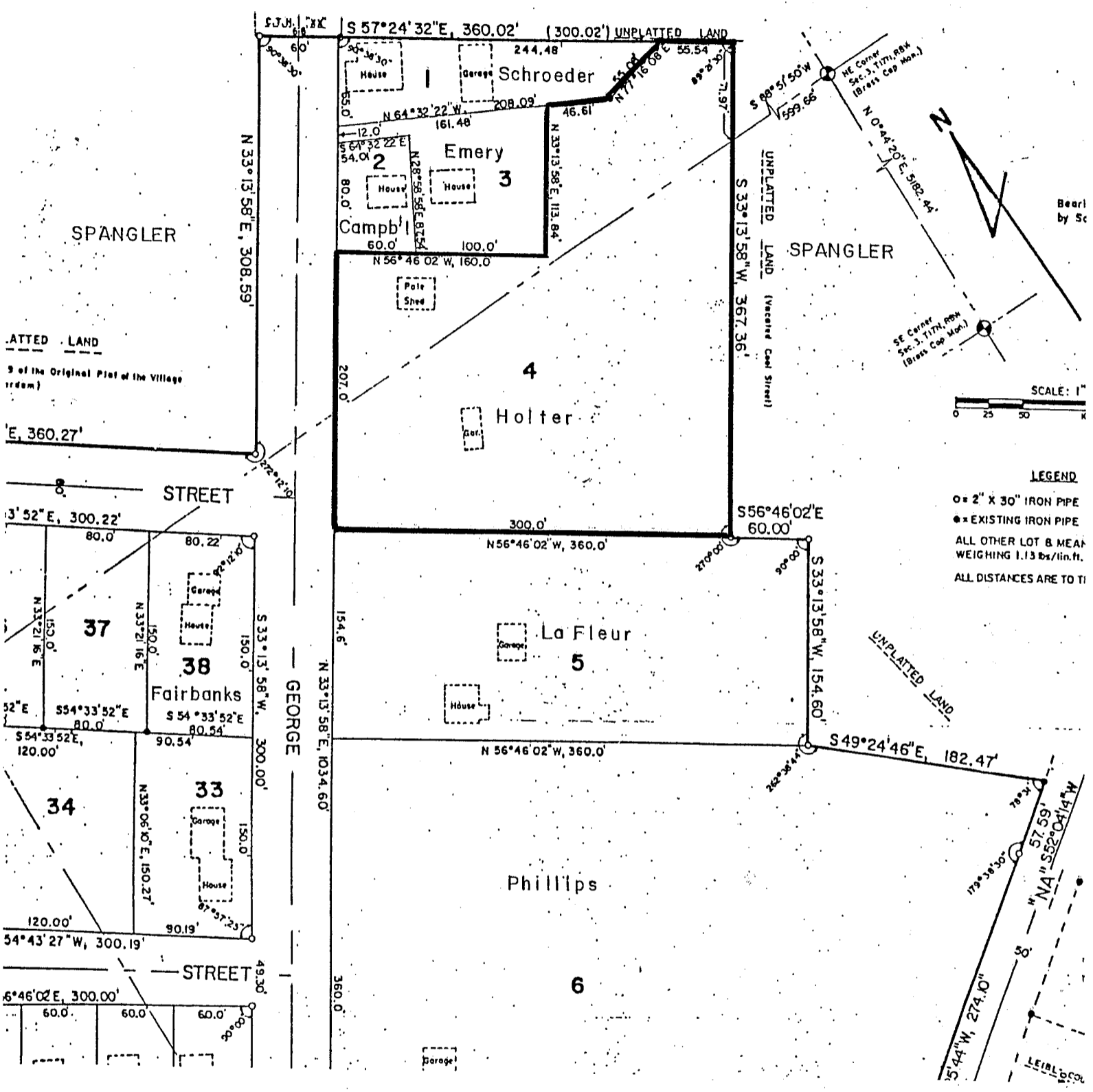
