by the County Board in January of 1979 to operate a cooperative health food business in the Town of Holland

**Reason for terminating** – The business has not operated during the past 12 consecutive months.

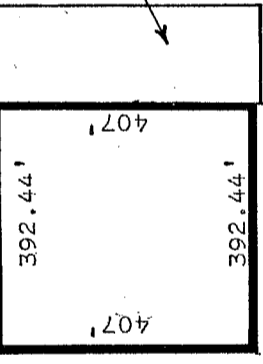
