and having held a public hearing on the 2nd day of March, 2009 on a petition to terminate Conditional Use

Permit No. 353 issued to Todd & Susan Clark, N5625 Sunset Dr, Onalaska, WI and passed by the County

Board on November 15, 1995 to operate a custom sewing and alteration business in their residence in the

Town of Onalaska

Reason for terminating – The business has not operated during the past 12 consecutive months.

The Committee and the affected Town Board(s), under s. 17.36(4), have the authority to approve the application with integral conditions or to disapprove of the application. By a vote of 6 in favor, 1 excused-Keil, the Committee recommended termination of Conditional Use Permit No. 353

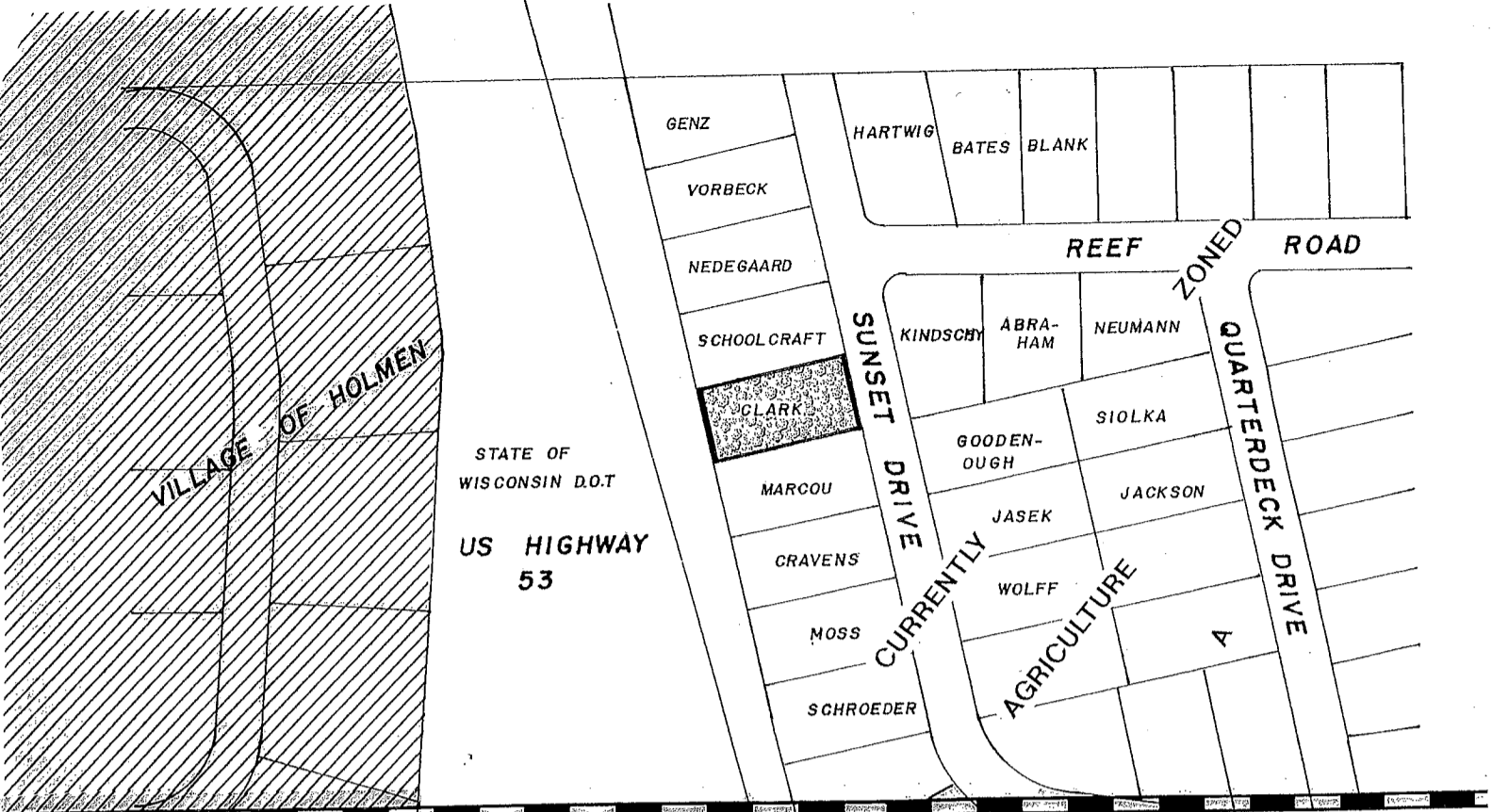
