TO THE COUNTY BOARD ON A HEARING FOR TERMINATION OF A CONDITIONAL USE PERMIT

TO THE COUNTY BOARD OF SUPERVISORS OF LA CROSSE COUNTY:

The La Crosse County Planning, Resources and Development Committee, having considered the application filed by:

LA CROSSE COUNTY ZONING, PLANNING AND LAND INFORMATION DEPARTMENT

and having held a public hearing on the 26th day of October, 2009 on a petition to terminate Conditional Use

Permit No. 355 issued to Dennis J Waller, W3865 Pump House Rd, Mindoro, WI and passed by the County

Board on March 21, 1996, to operate a fire arms business out of an existing residence on land zoned

AGRICULTURE DISTRICT "A" in the Town of Farmington. Reason for terminating - The fire arms business

has not operated for a period in excess of 12 consecutive months.

LAND DESCRIBED AS: Part of the SW-SE of Section 21, T18N, R6W commencing at the SW corner; thence N0°18'W to the NW corner; thence East along the North line 330' to the POB; thence East 75'; thence South 148'; thence West 75'; thence North 148' to the POB in the Town of Farmington.

And pursuant to s. 59.69 Wis. Stats. and s. 17.36 Zoning Code: the Committee did publish and receive proof of a Class II notice of the hearing; did receive receipts of mailing of the notices to the affected Town Clerk(s); did hold a public hearing to hear testimony or correspondence from the people; and, did receive and consider action from the affected Town Board(s). The Committee and the affected Town Board(s), under s. 17.36(4), have the authority to approve the application with integral conditions or to disapprove of the application. Having considered the entire record the Committee's recommendation is to: **TERMINATE.**

By a vote of 6 in favor, (1 excused-Meyer) the Committee recommended terminating Conditional Use Permit No. 355 for the reason stated above. The Union State Bank of West Salem is the current owner.



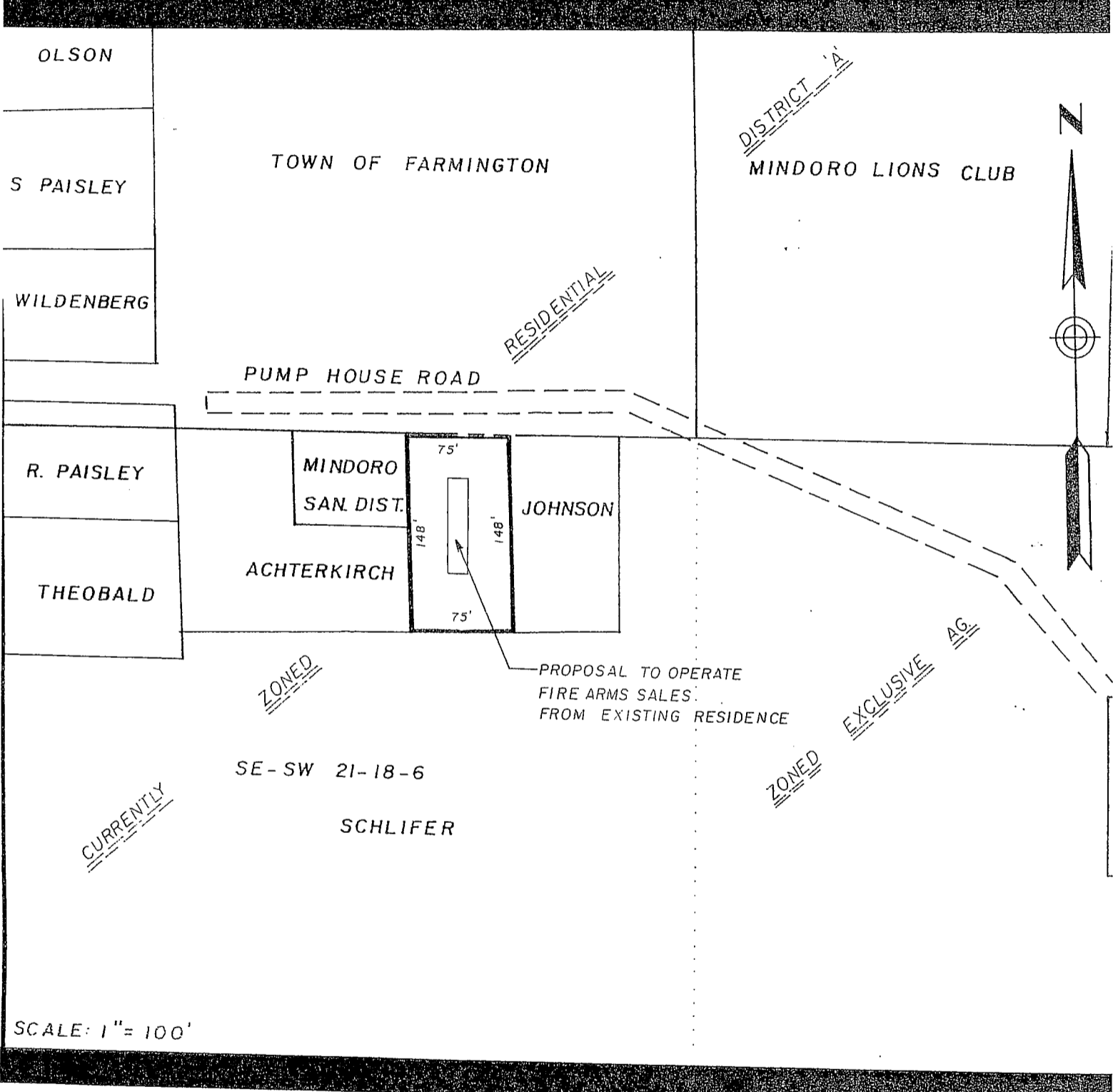
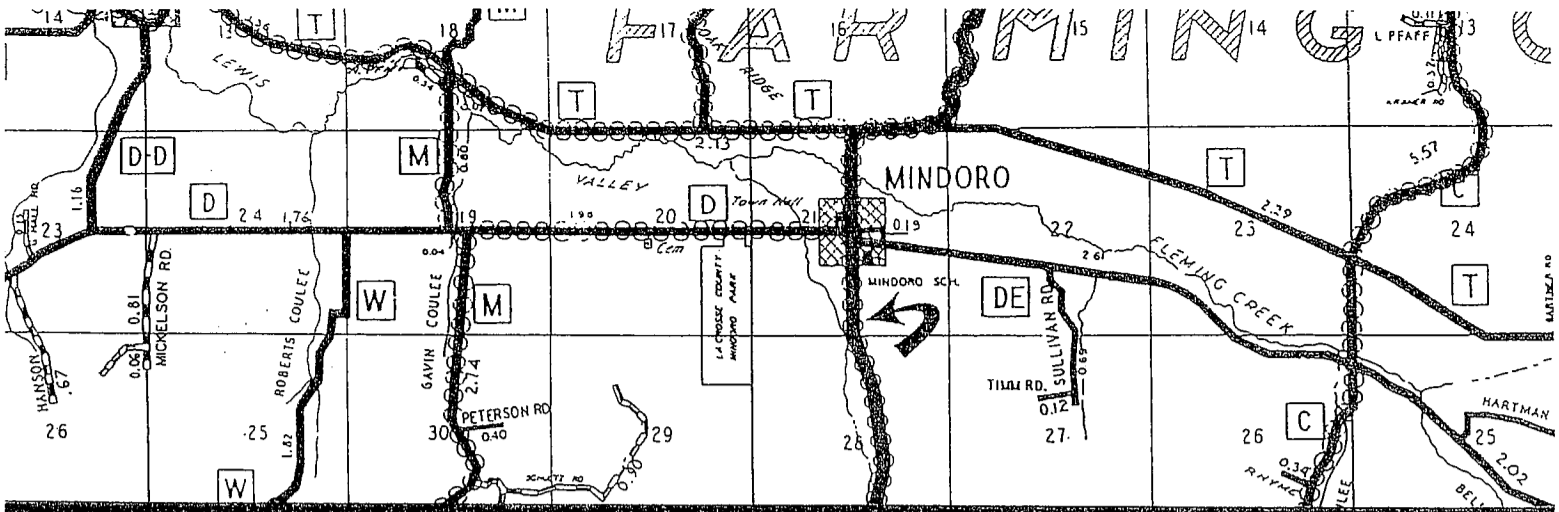
