RE: APPROVE TOWN OF ONALASKA LAND USE MAP

WHEREAS, the La Crosse County Comprehensive Plan 2007-2027 states that to keep current with municipal actions, the County will update the La Crosse County Future Land Use Map at least annually; and,

WHEREAS, the Town of Onalaska has adopted a Land Use Map (attached hereto as Exhibit A) delineating the land use districts in said town; and,

WHEREAS, the Planning, Resources & Development Committee recommends that the La Crosse County Future Land Use Map as set forth s. 31.03(4), page 113, of the County Comprehensive Plan be amended to incorporate the land use districts adopted by the Town of Onalaska Land Use Map (Exhibit A) pursuant to Wis. Stat. s. 66.1001(4).

NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board hereby approves the Committee's recommendation that the La Crosse County Comprehensive Plan Future Land Use Map be amended to include the land use districts established by the Town of Onalaska in Exhibit A, as a guide for future development activity and to aid the County Board in the performance of its duties.

BE IT FURTHER RESOLVED, that the County Planner is directed to bring an ordinance to the County Board at the appropriate time amending the La Crosse County Future Land Use Map including the land use districts adopted by the Town of Onalaska and the approved plans of other local government units.
