RE: DESIGNATION OF WRIGHT FARM AS A LA CROSSE COUNTY HISTORIC SITE

WHEREAS, the John and Razy Wright Farm located at W5670 County Road F in the Town of Medary in La Crosse County was nominated for County recognition as a historic site because the house retains unique features and remains as built with no exterior modifications and the minimal interior alternations; and,

WHEREAS, the house's unique features include English running bond stone construction and elaborate roof design, including rounded cornices over dormer windows; and,

WHEREAS, the historical site is legally described as follows: Lot One of Certified Survey Map No. 56 in Volume 11, Town of Medary, La Crosse County, Wisconsin; and,

WHEREAS, following a public hearing on October 2, 2009 the Historic Sites Preservation Commission approved adding the John and Razy Wright Farm, now owned by Daniel and Elizabeth Moen, as a historic site to the La Crosse County historic sites listing.

NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board does hereby approve adding the Wright Farm as a historic site to the La Crosse County historic sites listing.

BE IT FURTHER RESOLVED, that the designation of the Wright Farm as a La Crosse County historic site shall subject this site to all provisions of Chapter 23 of the General Code of La Crosse County and this resolution shall be recorded at the County's expense with the La Crosse County Register of Deeds Office.
