RE: ADOPTION OF CONTRACT FOR HILLVIEW LOCAL 150 UNION EMPLOYEES

WHEREAS, La Crosse County and the Hillview Local 150 Union have concluded collective bargaining negotiations for a successor union contract covering the period 2010, and;

WHEREAS, the parties have reached tentative agreement on all issues raised through collective bargaining.

NOW THEREFORE BE IT RESOLVED, that the tentative agreement of the parties for changes to this contract for the years 2010 which is attached hereto, including across the board wage increases of 2.0% January 1, 2010 and 1.0% July 1, 2010, be ratified as the changes to the working agreement between La Crosse County and the Hillview Employees Union, SEIU Local 150, effective as specified in the agreement when ratified by the Union.

BE IT FURTHER RESOLVED, that the Personnel and Finance departments are authorized and directed to take such action as is necessary to put said working agreement into effect and carry out the intent of this resolution.

FISCAL NOTE: The estimated increase in cost of wage, fringe benefits and rollups for 2010 is \$208,921, a package increase (over 2009) of approximately 3.40% of which .67% is insurance; there are approximately 138 employees in this bargaining unit.
