TO THE COUNTY BOARD ON A HEARING FOR TERMINATION OF A CONDITIONAL USE PERMIT

TO THE COUNTY BOARD OF SUPERVISORS OF LA CROSSE COUNTY:

The La Crosse County Planning, Resources and Development Committee, having considered the application filed by:

LA CROSSE COUNTY ZONING, PLANNING AND LAND INFORMATION DEPARTMENT  
400 4<sup>TH</sup> ST N - ROOM 3170 LA CROSSE WI 54601

and having held a public hearing on the 1<sup>st</sup> day of March, 2010 on a petition to terminate Conditional Use Permit No. 45 issued to Teunis Van Wyk, Rt 1, West Salem, WI and passed by the County Board in December of 1982, to operate a veterinary clinic on 4.96 acres of land zoned Agriculture District "A" in the Town of BARRE. **Reason for terminating** - The business has not been in operation of a period in excess of 12 consecutive months.

**LAND DESCRIBED AS:** Part of the SE-NW of Section 21, T16N, R6W, Beginning at the Southwest corner of said forty, thence North along the center of CTH-M 442.2 feet; thence East at a right angle 609.4 feet; thence S01°14'E 442.2 feet; thence West along the South line of said forty 619 feet to the place of beginning, and contains 4.96 acres, Town of Barre.


And pursuant to s. 59.69 Wis. Stats. and s. 17.36 Zoning Code: the Committee did publish and receive proof of a Class II notice of the hearing; did receive receipts of mailing of the notices to the affected Town Clerk(s); did hold a public hearing to hear testimony or correspondence from the people; and, did receive and consider action from the affected Town Board(s). The Committee and the affected Town Board(s), under s. 17.36(4), have the authority to approve the application with integral conditions or to disapprove of the application. Having considered the entire record the Committee's recommendation is to: **Terminate.**

**By a vote of 4 in favor (2 excused - Keil-Wehrs and 1 absent - Manthei) the Committee recommended approval to terminate Conditional Use Permit No. 45 for a veterinary clinic.**





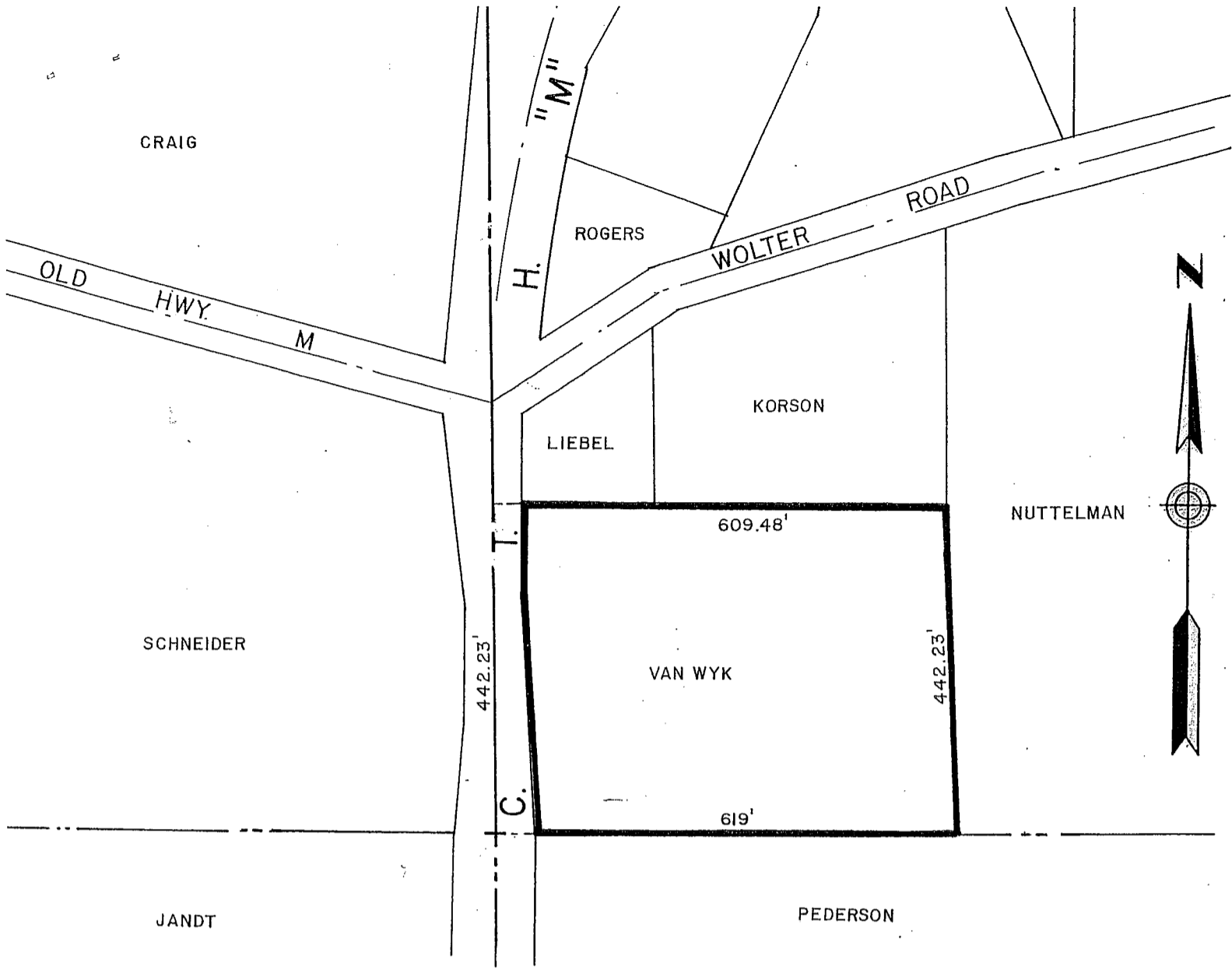
