RE: ACCEPT HEALTHY LIVING CONTRACT, INCREASE HEALTH EDUCATOR I HOURS BY .09 FTE - 3.5 HOURS/WEEK - AND HIRE A LTE WORK ASSISTANT FOR 150 HOURS BETWEEN MAY - SEPTEMBER 2011.

WHEREAS, the Health Department has received a Healthy Living contract for \$25,000 from the State of Wisconsin for 2011 to provide implementation funding for the Healthy Living Collaboration project to create a community environment that promotes healthy eating and activity choices; and,

WHEREAS, 2 out of 3 adults and 1 out of 3 children are overweight or obese; and,

WHEREAS, an existing Health Educator I would need to be increased from .66 to .76 Full Time Equivalents to meet the contract objectives; and,

WHEREAS, a work assistant will need to be hired for 150 hours between May 2011 and September 2011 to meet contract objectives;

NOW THEREFORE BE IT RESOLVED, that the Health Department is authorized to accept the Healthy Living contract for \$25,000 for the period January 1, 2011 - December 31, 2011, to hire a work assistant from approximately May 1st through September 30th, 2011 and to increase the hours of one existing Health Educator from .66 to .76 FTE for the length of the contract.

FISCAL NOTE: The cost of the additional hours for the length of the contract is \$4,384 for salary and \$ 683 for fringes for a total of \$ 5,067. The remaining funds will be used to meet contract objectives.
