TO: HONORABLE MEMBERS OF THE LA CROSSE COUNTY BOARD OF SUPERVISORS

RE: AGREEMENT FOR DOUBLE OCCUPANCY OF CELLS IN THE LA CROSSE COUNTY JAIL

WHEREAS, the La Crosse County Jail currently uses some cells for double occupancy of inmates and to continue this practice the County Board and Sheriff must meet certain conditions; and,

WHEREAS, the County Board and Sheriff are required to determine jointly the adequate staffing needs, including support staff and services, that are required to ensure the health, safety, and security of the jail staff and inmates when using cells for double occupancy; and,

WHEREAS, the County Board and Sheriff must reduce any joint determinations to writing, signed by the County Board Chair and Sheriff, and file such written joint determination with the State Department of Corrections; and,

WHEREAS, the written joint determination shall remain in effect until rescinded by mutual written agreement of the County Board and Sheriff; and,

WHEREAS, unless there is adequate staff as agreed upon by the County Board and Sheriff, double celling may not occur.

NOW, THEREFORE BE IT RESOLVED, that the La Crosse County Board does hereby approve a joint written agreement between the Board and the Sheriff that meets the conditions necessary to allow double occupancy of cells by inmates in the La Crosse County Jail.

BE IT FURTHER RESOLVED, that the La Crosse County Board Chair is authorized to sign the written agreement with the Sheriff as required by state law to provide for the double occupancy of cells in the La Crosse County Jail upon approval by the Corporation Counsel.

FISCAL NOTE: No additional cost to La Crosse County for entering into a written agreement with the Sheriff to allow for double occupancy of jail cells.
