WHEREAS, Wis. Stat., s. 92.10 created a county land and water resource management program in Wisconsin; and,

WHEREAS, the planning program requires counties to develop land and water resource management plans that identify soil and water resource concerns and the methods to protect and enhance those soil and water resources; and,

WHEREAS, the La Crosse County Land and Water Resource Management Plan 2012-2017 has been developed as the implementation document to protect the County's soil and water resources and to fulfill statutory requirements which will allow the Department of Land Conservation to receive implementation grants from the State of Wisconsin; and,

WHEREAS, the Planning Resources and Development Committee held a public hearing on the Land and Water Resource Management Plan on September 20, 2011 and recommends the approval of such Plan as being in the best interests of La Crosse County.
