TO THE COUNTY BOARD ON A HEARING FOR TERMINATION OF A CONDITIONAL USE PERMIT

TO THE COUNTY BOARD OF SUPERVISORS OF LA CROSSE COUNTY:

The La Crosse County Planning, Resources and Development Committee, having considered the application filed by:

LA CROSSE COUNTY ZONING, PLANNING AND LAND INFORMATION DEPARTMENT

and having held a public hearing on the 31st day of May, 2011 on a petition to terminate Conditional Use Permit No. 710 issued to Tim Boyd for Airborne Datalink, 709 Gillette St. La Crosse, WI; current owner David Spencer, for Airborne Wireless, 3148 Edgewater Dr, La Crosse, WI 54603, and passed by the County Board February 16, 2006 to operate a 100-ft telecommunications tower and facility on land owned by Thomas Kendhammer, N3510 Peters Rd, La Crosse, WI 54601 on land zoned Agriculture District "A" in the Town of Medary.

Reason for terminating - the facility is not in compliance with the Conditional Use Permit provisions and Requirements of La Crosse County Code of Ordinances Chapter 28.

LAND DESCRIBED AS: Lot 1 of Certified Survey Map No. 159, Volume 12 in Section 22, T16N, R7W. Town of Medary.

And pursuant to s. 59.69 Wis. Stats. and s. 17.36 Zoning Code: the Committee did publish and receive proof of a Class II notice of the hearing; did receive receipts of mailing of the notices to the affected Town Clerk(s); did hold a public hearing to hear testimony or correspondence from the people; and, did receive and consider action from the affected Town Board(s). The Committee, under s. 91.48(1), Wis. Stats., along with the affected Town Board(s), under s. 17.36(4), have the authority to approve the application with integral conditions or to disapprove of the application. Having considered the entire record the Committee's recommendation is to:


