**ANALYSIS**

The amendment is a housekeeping change to reflect the practice of the County Board Chair appointing at least one Supervisor as an at-large member of the Executive Committee. Such appointment may be needed to meet the 9 membership requirement regardless of whether any of the Vice Chairs are also chairs of a Standing Committee.

**INFORMATION:**

County Board Rules: Governing Body s. 2.02(8) states, in part: Ordinances are drafted by the Corporation Counsel. After the ordinance has been reviewed by a standing committee, each Supervisor will be given a copy of the ordinance showing the deleted language (grayed) and the new language (underlined) and an analysis of the intent of the ordinance. After introduction to the County Board, the ordinance shall be referred to the next monthly meeting unless waived by a 2/3 vote of the Supervisors present and a public hearing may be held if requested by a Supervisor. An amendment may be introduced and debated at either the original or the referred meeting. **ORDINANCE #100 - 4/2012**

**AN ORDINANCE TO AMEND S. 1.42(1) OF CHAPTER 1  
OF THE GENERAL CODE OF LA CROSSE COUNTY, WISCONSIN  
REGARDING EXECUTIVE COMMITTEE MEMBERSHIP**

The County Board of Supervisors of the County of La Crosse does hereby ordain as follows:

**Section 1.** Section 1.42(1) of the County Code is amended to read:

1.42 EXECUTIVE COMMITTEE

(1) Membership. The Executive Committee shall be composed of the County Board Chair, the 2 Vice Chairs, and the Chair of each Standing Committee. The County Board Chair shall be the chair of the Executive Committee. The County Board Chair may appoint additional Supervisors to the Executive Committee to maintain the membership at 9 Supervisors. In addition, the immediate past County Board Chair may serve as a member of the Executive Committee for 1 year from the last date that he or she held office as County Board Chair provided that he or she continues to be a Supervisor.

**Section 2.** This Ordinance shall take effect the day after passage and publication as required by law.
