### ORDINANCE

#### ANALYSIS

This Ordinance creates a slow, no-wake zone in that waterway known as Bluff Slough (also known as Swift Creek or Running Slough) located in the City of La Crosse and the Town of Shelby and adjacent to the southwest corner of 2514 Riverside Drive on the North boundary and adjacent to the lot line between 2808-2810 and 2816 -2818 Huber Court on the South boundary.

#### **INFORMATION:**

County Board Rules: Governing Body s. 2.02(8) states, in part: Ordinances are drafted by the Corporation Counsel. After the ordinance has been reviewed by a standing committee, each Supervisor will be given a copy of the ordinance showing the deleted language (grayed) and the new language (underlined) and an analysis of the intent of the ordinance. After introduction to the County Board, the ordinance shall be referred to the next monthly meeting unless waived by a 2/3 vote of the Supervisors present and a public hearing may be held if requested by a Supervisor. An amendment may be introduced and debated at either the original or the referred meeting. ## ORDINANCE <u>#101 - 1/12</u>

# AN ORDINANCE TO CREATE S. 30.81(11) OF CHAPTER 30 OF THE GENERAL CODE OF LA CROSSE COUNTY, WISCONSIN REGARDING SLOW NO-WAKE ZONES

County Board of Supervisors of the County of La Crosse does hereby ordain as follows:

**Section 1:** Section 30.81(11) is created to read:

There shall be a slow no-wake zone in that part of the waterway 30,81(11). known as Bluff Slough, which is a backwater of the Mississippi River, located in the City of La Crosse and the Town of Shelby, legally described as: All that part of the SW1/4 of the SE1/4 of Section 8, City of La Crosse; and that part of the NW1/4 of the NE1/4 of Section 17, Town of Shelby; and that part of the NE1/4 of the NE1/4 of Section 17, City of La Crosse, all in Township 15 North, Range 7 West described as follows: Commencing at the northeast corner of said NW1/4 of the NE1/4; thence South along the east line thereof, being also the boundary between the City of La Crosse and the Town of Shelby 532 feet to the point of beginning; thence Northeasterly 200 feet to the southeast corner of Lot 17, Huber Homes, which is on the lot line between 2808-2810 and 2816-2818 Huber Court; thence Northeasterly along the easterly shore line of Bluff Slough (also known as Swift Creek or Running Slough) 2,025 feet more or less to a point 233 feet south of the north line of said SW1/4 of the SE1/4 of Section 8, said point being the southwest corner of 2514 Riverside Drive; thence Southwesterly at a right angle to the shore line 325 feet to the westerly shore line of Bluff Slough; thence Southeasterly along the westerly shore line of Bluff Slough a distance of 2,100 feet more or less to the point of beginning.

**Section 2:** This Ordinance shall take effect the day after passage and publication as required by law.
