**RE: APPROVAL OF MARKET VALUE PRICING FOR SPECIALTY WASTE DELIVERED TO  
THE NSP RDF FACILITY**

**WHEREAS**, the La Crosse County Solid Waste Department has been presented with recycling opportunities in the past, where certain specialty wastes could be available from outside of the existing La Crosse County service area to be delivered to the NSP RDF Facility but where the price may discourage delivery; and,

**WHEREAS**, the delivery of such specialty wastes at market value pricing would allow for a discounted price to be offered for recycling opportunities, such as disposal of paper and swine filters, which would otherwise not be delivered to the RDF Facility; and,

**WHEREAS**, providing such waste to the RDF Facility will off-set losses which La Crosse County suffers due to waste diverted from the La Crosse County service area, provide increased energy value, and support recycling of resources; and,

**WHEREAS**, the receipt of such specialty waste will not interfere with existing municipal waste contracts.

**NOW, THEREFORE BE IT RESOLVED**, that the La Crosse County Board hereby approves allowing market value or discounted pricing for new specialty wastes from outside of the La Crosse County service area to be delivered to the NSP RDF Facility.

**FISCAL NOTE:** No investment is required. Receipt of additional waste will help La Crosse County meet its guaranteed annual tonnage obligation to NSP.
