RE: SUPPORT THE REOPENING OF THE BANGOR, WISCONSIN POST OFFICE

WHEREAS, the post offices in small rural communities serve as important and sometimes exclusive points of contact and communication for many citizens in those communities; and,

WHEREAS, on January 11th, 2012, the U.S. Postal Service closed the Bangor, Wisconsin post office due to building safety and health concerns; and,

WHEREAS, closure of this facility has negatively impacted the community of Bangor, and a petition is being circulated in an effort to have the post office reopened; and,

WHEREAS, community members have requested our support in this effort.

NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board of Supervisors respectfully requests the US Postal Service to reopen the Bangor Post Office, either by making sure the existing location is upgraded to proper standards or by obtaining a new facility within the Village of Bangor.

BE IT FURTHER RESOLVED, that a copy of this resolution be mailed to Postmaster General Patrick Donahoe, U.S. Senator Ron Johnson, U.S. Senator Herb Kohl and Rep. Ron Kind.
