WHEREAS, Jennifer Wall purchased the vacant property from the County of La Crosse on July 5, 2011 located at 1506 Black Oak Drive, Rockland WI 54653 for the sum of \$17,000; and,

WHEREAS, Jennifer Wall no longer wishes to own the property, and it is in the best interest of La Crosse County to purchase said property back from Jennifer Wall for the sum of \$17,000; and,

WHEREAS, it has been represented to La Crosse County that Coulee Cap will purchase said property back from La Crosse County in the near future.

NOW, THEREFORE, BE IT RESOLVED that the La Crosse County Board hereby authorizes the purchase of the property at 1506 Black Oak Drive, Rockland WI 54653, parcel #15-328-0, for the sum of \$17,000.

BE IT FURTHER RESOLVED, that the County Board Chair shall be authorized to sign any documents necessary to accomplish the purpose of this resolution, after approval of Corporation Counsel.

FISCAL NOTE: Cost to La Crosse County is \$17,000 plus closing costs. Funds shall be paid from the General Contingency Fund, Org. 1063, Account 79028.
