RE: ADOPTION OF CITIZEN PARTICIPATION PLAN FOR THE SOUTHWEST HOUSING CONSORTIUM

WHEREAS, La Crosse County plans to apply for a Community Development Block Grant as part of its participation in the Southwest Housing Consortium; and

WHEREAS, the State of Wisconsin Department of Administration and the U.S. Department of Housing and Urban Development require recipients of Community Development Block Grant monies to have in place a Citizen Participation Plan; and,

WHEREAS, the Citizen Participation Plan shall encourage citizen participation, with emphasis on participation by persons of low to moderate income, and shall provide citizens reasonable and timely access to local meetings and information; and,

WHEREAS, the Citizen Participation Plan shall also require the establishment of a Citizen Participation Committee, composed of 5 members appointed by the County Board Chair and representing the community's demographics; and,

WHEREAS, the Executive Committee has reviewed and approved a Citizen Participation Plan.

NOW, THEREFORE BE IT RESOLVED, that the La Crosse County Board hereby adopts the Citizen Participation Plan, which is attached hereto as Exhibit A.
