CALL TO ORDER

The meeting was called to order at 12:00 noon.

PUBLIC COMMENT

There was no public comment.

APPROVAL OF NOVEMBER 11, 2009 MINUTES OF THE CRIMINAL JUSTICE MANAGEMENT EXECUTIVE COMMITTEE

The November 11, 2009 minutes of the CJMC Executive Committee were approved as submitted.

VETERANS COURT

Nothing to report at this time.

UPDATE ON COMMUNITY TRAINING

Judge Perlich and Jane had a discussion with Mark Carey regarding taking Evidence Based Practices training to the next level. It turns out that there is an initiative by the National Institute of Corrections that is geared towards this. Judge Perlich had a draft of the report that the NIC is preparing to issue that is based on the following four principles:

- 1. Using evidence based practices to guide actions and decision making.
- 2. Every justice person or system who has any contact with an offender, is an opportunity to change that offender's behavior.
- 3. All of these people have to collaborate to achieve what they want to achieve.
- 4. They collect data to measure success.

The entire group (people from all of the systems) would go through 2 days of training. At the end of these 2 days, they would need to make a decision about whether or not to adopt this system. They would then get together every month or so to collect data to see how they're doing. Are they following the Evidence Based Practices, etc?

The National Institute of Corrections would like to move this to a pilot program and then field test it with a local jurisdiction to assimilate implementation. Judge Perlich will propose at the CJMC retreat that we take a shot at being in their pilot program.

TJC INITIATIVE UPDATE

This is the Urban Institute technical assistance initiative that focuses on making community connections. Residential treatment is very expensive and also the numbers have been reduced due to a focus on outpatient treatment and outreach services. Two of the biggest issues are housing and employment issues, but residential should not be used for that purpose. We will be putting more service providers in the homes to see how they're doing. It would be ideal to have everyone use a standardized tool for Screening & Assessment, and also a Standardized Release of Information tool.

OTHER MISCELLANEOUS ITEMS

Judge Levine has been following the change in the OWI laws. The main change is the base OWI 3rd mandatory jail time increased dramatically. This may mean that we have more electronic monitoring days for 3rds and above. Probably the other issue that we may run into is the ignition interlock for 2nds and above, but it does mean that people will not be able to get their licenses unless they have the funding for these devices.
