#### **UPDATE ON NATIONAL REGISTER NOMINATION WITH REMAINING FUNDS**

Vicki reported that she has been in contact with the Historical Society about a nomination of the Neshonoc Dam and Powerhouse and/or the Swarthout House. She was told that in 2000, the Swarthout House was deemed ineligible for the historic register, but they have requested more recent photos for reconsideration of both the Swarthout House and Neshonoc Dam and Powerhouse. Vicki has forwarded pictures of the Neshonoc Dam and Powerhouse. The owner of the Swarthout House was not interested in pursuing a local nomination at this time, so likely would not be interested in pursuing a National Register Nomination.

# UPDATE ON PLAQUE FOR WRIGHT FARM DESIGNATION AS HISTORIC SITE

Vicki reported that an inscription is included in the plaque price. She brought a rough draft of some wording. Suggestion was made to include the year the house was built, and she will bring back a re-draft showing the layout. Discussion was held regarding use of the County logo, and Vicki will check with Corporation Counsel on whether it can be used.
