### COUNTY BOARD CHAIR REPORT – 1<sup>st</sup> Vice Chair Tara Johnson **RESOLUTION #87-3/10 RE: RECOGNITION OF LONG AND FAITHFUL SERVICE** OF JOHN E. FLYNN

WHEREAS, Mr. John E. Flynn was appointed by then County Board Chairman John Thomas to the La Crosse County Highway Safety Committee between 1963 and 1965 serving as legal representative and on occasion, acting officer, and continued his interest and input as a member until his retirement in 2010; and, WHEREAS, Mr. Flynn was an assistant DA and then the District Attorney for La Crosse County, served as secretary for the Wisconsin District Attorney Association in 1964, was past president of the La Crosse County Bar Association and a member of the Wisconsin State Bar and the American Bar Association and the Association of Trial Lawyers; and, WHEREAS, Mr. Flynn was Corporation Counsel for La Crosse County from 1955 to 1965; and, WHEREAS, Mr. Flynn was a commissioner of the La Crosse Housing Authority for 15 years, a director for the Greater La Crosse Area Chamber of Commerce and served as an Ambassador of the Chamber for over 30 years. He served as legal counsel for the La Crosse Lutheran Hospital Foundation for over 17 years, and was active on the St. Joseph the Workman Cathedral Parish council where he was also a past president; and, WHEREAS, Mr. Flynn was an attorney with Klos, Flynn & Papenfuss since before 1965 until he retired 2 ½ years ago. During his career as a private attorney he was the lead local attorney representing the developers of the Valley View Mall. Mr. Flynn worked with the following to see that the required road needs were met to obtain the mall: County Highway Committees, the County Board, City Engineering Department, La Crosse

# • Supervisor Conference Reports

- Solid Waste Conference: Supervisor Benrud attended a conference in February with Solid Waste Director Koch. He shared what he learned there with the Public Works and Infrastructure Committee
- Transportation Development Association in Washington D.C. in March. It was well attended; health care and transportation were top priority issues. There is a bill that got a green light from the Senate on renewing highway programs for 2010 that would deposit \$20 billion in the Highway Trust Fund; that bill went to the Assembly yesterday and may have been signed into law today.
- Governors Conference on Tourism: Supervisor Benrud attended the Governors Conference on Tourism, which she chairs for ITBEC. She learned that airline fees are up 40% and many airways are cutting amenities.
- High Speed Rail Summit: Supervisor Richmond thanked Administrator O'Malley for this meeting today. It was a great get-together of rail officials and the DOT and other dignitaries from Wisconsin and Minnesota and those attending to show support. She asked that he announce the next meeting as that would be helpful for a good turnout. O'Malley responded that the next meeting of the High Speed Rail Coalition will be 7:30 Friday morning, March 26<sup>th</sup> in the 3<sup>rd</sup> floor conference room at City Hall. Supervisor T. Johnson agreed with Richmond and felt that she spoke for the many supervisors who attended.
- Governors Conference on Tourism: Supervisor Sebranek also attended this conference as a representative of SW ITBEC (Southwest International Trade, Business and Economic Development Council). Others representing La Crosse County were Benrud, ITBEC Chair Jim Ehrsam and Steve Peterson. There were keynote speakers, workshops and breakout sessions. Awards were given out after the Governor's dinner. Their booth gave away donated rooms from the Radisson and the Marriott.

- WCA Human Services Day: This Madison event was a first and Supervisor Wood attended with Supervisors Billings and Hampson, County Human Services Director Gerald Huber and Lakeview Administrator Pam Semb. It was attended by over 150 county officials and key challenges were discussed. The event included strategy sessions where key challenges were discussed, such as age of juvenile court jurisdiction, use of federal stimulus funds, human services financing in county homes and multi county collaboration.
- WCA Human Services Day in Madison: Supervisor Billings added that it was good to have staff with them when they met with area legislators. They left there with the legislators understanding that even though Human Services has been hit hard by budget cuts we are not just doing nothing and asking for more money. We have developed initiatives to deliver services more effectively.
- Couleecap and ARRA Funding: Supervisor Billings noted that she and Supervisor Fisher are the County representatives to Couleecap. Because Couleecap has been in existence for 44 years, they were able to acquire ARRA funding, with legislative support, as they already have a structure to deliver services to people in poverty. It has resulted in 20 new jobs and assistance to 105 local residents.
- Town of Campbell Flood Control: Supervisor Schroeder attended a meeting where Emergency Management Coordinator Keith Butler facilitated discussion on flood preparedness. Butler was very helpful to the Town by pointing out important things to add to the current Plan.
- ARRA Funding: Supervisor Hampson announced there will be a press conference tomorrow at 1:00 at the Hogan Administrative Center about funding that the Health Department is receiving for expansion of preventative health services in the areas of tobacco and obesity.

# COUNTY ADMINISTRATOR REPORT – Steve O'Malley

- Legislative Ideas for Wisconsin Counties Association (WCA): On behalf of our Legislative Committee, he shared the importance of getting all our resolutions in by the end of June. He is asking all governing committees to put this on their agenda to discuss ideas so resolutions can be prepared and passed before the end of June in order to be included as a potential item for the Legislative Platform at the Fall WCA conference. He noted that the governor signed the public defender bill this week and that is a result of county input. He stressed that it is important that we remain active with our legislators and that we can have an impact. Supervisors should bring their ideas to him, and the sooner the better. He will get them to the Legislative Committee. Vice Chair Johnson suggested they include their Committee chairs when appropriate.
- Indigent Burials Per request supervisors were given information on the cost of burials to La Crosse County. The summary showed those costs from 2007-2009. The criteria required for the County to fund the burial costs are:
  - La Crosse County resident at time of death
  - Ineligible for Medicaid at time of death
  - Insufficient resources to cover "allowable burial expenses"
    - Funeral costs of all goods or services provided by the funeral home, including transportation, provided total cost does not exceed \$1,000. If total funeral costs exceed \$1,000, no payment is authorized.
    - Cemetery costs of all goods or services provided by the cemetery, including cremation, provided total cost does not exceed \$1,000. Again no payment is authorized if total costs exceed \$1,000.

The program is funded 100% through county property taxes. In the past 3 years, there were 57 indigent burials at an average cost of \$1,499 per burial. In addition, the County has a contract with the Wisconsin Department of Health Services (DHS) to administer the Wisconsin Funeral and Cemetery Aids Program (WFCAP), also referred to as the "MA Burial Program". This is 100% state funded and is available to individuals who are receiving

Medicaid or another qualifying healthcare program under the DHS at the time of their death. These reimbursement requests must come directly from a funeral home or cemetery. Allowable burial costs under this program include funeral cost reimbursement up to \$1500 if the expense is \$3,500 or less, and cemetery cost reimbursement up to \$1,000 if the expense is \$3,500 or less. If the expense for either exceeds \$3,500, no reimbursement is allowed. In the past 3 years, there were 270 MA Burial Program reimbursements at an average cost of \$2,018 per burial. Administrator O'Malley, Economic Support Manager Lori Graff and Fiscal Services Manager Sara Koopman responded to questions from the Board.

- Employee Demographics Per request supervisors were given a Demographic Report compiled by La Crosse County's Personnel Department. As of December 2009 we had 1397 employees, 258 of which were part time or irregular part time (on call, seasonal, temporary or less than half time).
  - Females 982 (70%)
  - Males 416 (30%)
  - Per 6/30/09 Minority Status report for EEO (Equal Employment Opportunity)
    - Native American 4
    - Black / African American 4
    - o Asian 33
    - o Hispanic 5

These minority figures may not include self-identified mixed race individuals as census figures do. Although we appear to be currently under represented by minorities, we have seen increasing numbers of minority applicants since our job listings go statewide through the Job Service network and our website can be accessed by computer nationwide.

Discussion ensued. Supervisor Medinger appreciated the figures and the effort that's being made.

# FIRST CONSIDERATION OF AN ORDINANCE

PLANNING, RESOURCES AND DEVELOPMENT COMMITTEE: ORDINANCE NO. 80 TO CREATE S.1.65 ENTITLED "FARMLAND PRESERVATION COMMITTEE" AND CHAPTER 32 ENTITLED "FARMLAND PRESERVATION" OF THE GENERAL CODE OF LA CROSSE COUNTY, WISCONSIN Meyer presented the ordinance for its first consideration and retained the floor. # RESOLUTION 88-3/10 RE: SUPPORT OF LEGISLATION TO CREATE REGIONAL TRANSIT AUTHORITIES (RTAs)

**WHEREAS**, Regional Transit Authorities (RTAs) will create jobs, spur development and economic growth, attract business and investors, and build the competitiveness of the State of Wisconsin in the global economy; and, **WHEREAS**, while other states across the country

have implemented RTAs to invest in transit, the Wisconsin transit systems continue to decline under antiquated funding structures that cut off economic opportunities and exacerbate job losses; and, WHEREAS, Wisconsin cannot afford to fall behind as we work to rebuild our economy and grow new jobs nor, can Wisconsin delay in taking action to reduce harmful air pollution and dependence on oil; and, WHEREAS, allowing all regions of the State of Wisconsin to form self-supporting RTAs will grow Wisconsin jobs: by spurring development that creates family supporting jobs, by creating linkages that draw a talented workforce and build the regional economy, by making our state more competitive in attracting business and jobs, by supporting transit system expansion both construction and manufacturing industries will be stimulated and by sustaining transit operations that hire locally; and, WHEREAS, allowing communities to form RTAs will build stronger Wisconsin communities: by successfully competing for federal infrastructure dollars, by reducing the cost of living and increasing household savings and spending power, by creating access to jobs, medical services and social opportunities for those who are unable or who do not drive, by generating government revenues as a result of boosting property values, by stimulating tourism, by getting people working by easing costly and dangerous traffic congestion, by fostering more efficient land development and by giving our communities a competitive edge in attracting and retaining business and residents by modernizing our outdated transportation system; and, WHEREAS, RTAs will also make Wisconsin healthier and cleaner: by supporting transit choices that reduce air emissions, by lowering health care costs for asthma and keeping communities in compliance with air guality standards to avoid costly pollution sanctions on manufacturing sources, by reducing the demand for parking and other paved areas from which runoff degrades water quality and triggers costly antipollution measures, and by cutting death and injury rates from transportation crashes, thereby saving lives, reducing health care costs, and avoiding time lost from work. NOW **THEREFORE BE IT RESOLVED**, that the La Crosse County Board does hereby support the creation of Regional Transit Authorities and urges the passage of legislation that authorizes Western Wisconsin and other communities the choice of creating a RTA that is a public body corporate and a separate government entity that may operate a comprehensive unified local transportation system on a region-wide basis. BE IT FURTHER RESOLVED, that the County Clerk shall send a copy of this resolution to area legislators, Governor James Doyle and other interested parties who are concerned about this issue. FISCAL NOTE: There is no fiscal impact to La Crosse County in supporting the passage of legislation to create RTAs.

WHEREAS, the attached Three-Year Harbor Development Statement of Intentions described proposed improvements which are in the best interest of the Port of La Crosse; and, WHEREAS, the Wisconsin Department of Transportation requires a statement of project intentions from local units of government intending to apply for federal and/or state aid for harbor-related work of any type within the next three years; and, WHEREAS, the Executive Committee has reviewed the estimated project costs, funding sources, physical location and alternatives to the proposed project; and, WHEREAS, the improvement proposed in calendar year 2012 is to engineer and install two tripod barge tie-off structures

for the lower end of the Harold E. Craig Fleeting Facility along with 200 linear feet of rip rap for bank protection throughout the area; and, **WHEREAS**, this Three-Year Harbor Development Statement of Intentions is used by the Wisconsin Department of Transportation for planning purposes only, and it does not commit La Crosse County to move ahead with the project. The Statement of Intentions simply makes the County eligible to make an application at some future date if funds become available. **NOW THEREFORE BE IT RESOLVED**, that the La Crosse County Board hereby approves the attached Harbor Development Statement of Intentions for the years 2011-2013. **FISCAL NOTE:** Funding sources for 2012 proposed improvement project are: 2 years worth of fleeting rental – \$30,000 and potential DOT Harbor Assistance Program (HAP) FUNDS - \$120,000.

#### **RESOLUTION #90-3/10 RE: MEDICAL ASSISTANCE (MA) TRANSPORTATION**

WHEREAS, transportation is a quality of life issue for everyone, especially for those individuals that are elderly or disabled and are no longer able to drive; and, WHEREAS, La Crosse County utilizes federal and state transportation funds that are received as a fixed amount from the Department of Transportation (DOT) to provide transportation for a variety of consumers through the La Crosse County Aging Unit; and, WHERAS, the Medical Assistance Program (MA) currently pays for the transportation of MA consumers to medical appointments; and, WHEREAS, under a plan proposed by the State Department of Health Services (DHS), the State is sending out a Reguest for Proposals (RFP) to hire a private vendor to coordinate transportation on a state-wide basis; and, WHEREAS, there is considerable concern among public and private agencies that deal with the transportation needs of the elderly and disabled that there will be a potential shift of transportation funding from non-Medical Assistance sources (s85.21, s85.20, 5307, 5311 and local government contributions) to pay for the transportation of MA consumers to their medical appointments; and, WHEREAS, the state and federal funding sources limit the county transportation program serving the general elderly and disabled population to charge only a portion of the trip cost (i.e. a 1 way trip that costs \$14.00 may only require a consumer co-payment of \$3.50), while currently MA pays the full cost of a trip; and, WHEREAS, the new program proposed by DHS would eliminate the payment of the full cost of transportation for MA consumers and require the transportation of MA consumers at the \$3.50 rate thus shifting the difference between the co-payment and actual cost of the ride from MA to the non-Medical Assistance transit funding sources; and, WHEREAS, the result of shifting the cost of MA rides to non-MA funding sources will cause the Aging Unit to run out of transportation funds to serve the transportation needs of the elderly and disabled populations by May, 2011 thus eliminating the service or shifting the cost to the county tax levy. NOW **THEREFORE BE IT RESOLVED**, the La Crosse County Board supports coordination and the use of cost effective methods to provide transportation to MA consumers and its elderly and disabled citizens; however, the State of Wisconsin DHS and DOT must collaborate and ensure that proper safeguards are in place to prevent a shift in transportation funding that would eliminate transportation services to the elderly and disabled populations thus affecting their guality of life. FURTHER BE IT RESOLVED, that the County Clerk shall send a copy of this resolution to Governor Jim Doyle, Senator Kapanke, Representative Schilling, and Representative Huebsch. FISCAL NOTE: The Aging Unit projects that the annual cost to County taxpayers would range from \$193,000 to \$578,000 to maintain existing transportation services to the elderly and disabled populations in La Crosse County if there is a shift in funding from MA to non-MA transit funding sources.

# RESOLUTION #91-3/10 RE: SUPPORT HEALTHIEST COUNTY 2015 – LA CROSSE COMMUNITY HEALTH IMPROVEMENT PLAN

**WHEREAS**, thousands of La Crosse County residents suffer or die from preventable disease or injury each year as determined by the La Crosse COMPASS Community Needs Assessment and the La Crosse Medical and Health Science Consortium Health Status Scorecard; and, WHEREAS, the La Crosse Medical and Health Science Consortium recently released "Healthiest County 2015: La Crosse," a community health improvement plan to enable the people of La Crosse to be the healthiest population in Wisconsin developed through the effort of over 50 organizations, including county employees; and, WHEREAS, the County of La Crosse Board of Supervisors can play a major role in reaching this goal through the services it delivers for alcohol misuse/prevention, traffic safety, exercise, nutrition, health promotion, disease and injury prevention, and other services. NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board of Supervisors direct staff to take steps needed to enable the County to reach the goal of being the healthiest County in the State by 2015. FISCAL NOTE: No specific County tax levy funds are requested for this effort. Instead, staff from many departments are asked to focus resources toward implementing those programs that are shown to be effective in protecting and promoting the health of the public.

FISCAL NOTE: The total amount owing = \$159.12 consisting of unpaid general property taxes in the amount of \$108.05, and unpaid penalty and interest in the amount of \$51.07.

NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board hereby authorizes the sale of parcel #17-20029-025, consisting of .005 acres more or less, to the City of La Crosse for the sum of \$1,129.58. BE IT FURTHER RESOLVED, that the County Board Chair and County Clerk are authorized to sign a Quit Claim Deed conveying this property to the City of La Crosse, upon approval by Corporation Counsel. FISCAL NOTE: The total amount owing equals \$1,778.70 as of March, 2010, consisting of unpaid general property taxes and special assessments -\$1,129.58, interest - \$433.12, and penalty - \$216.00.
