# **XCEL ENERGY ANNUAL REPORT**

Mike Herro, Community Service and Key Account Team Manager for Xcel Energy, introduced himself and Senior Environmental Analyst Christine Ball and French Island Plant Manager Mark Paitl. He referred to the detailed and lengthy report, much of which is compiled by Analyst Ball. The report Executive Summary consisted of the following:

- Xcel Energy's French Island Generating Plant employed 31 people in 2009. Its two boilers operated a total of 9158 hours and including its two combustion turbines, the plant generated 75, 217 MWH of electricity enough to serve nearly 10,000 homes.
- The plant had zero permit limit exceedances in 2009. Plant personnel gave plant tours to 730 citizens. This included many college and grade school students, local regulators and state government officials as well as many local civic groups and business representatives.
- The activated carbon injection (ACI) systems installed in 2007 (Boiler 2) and 2008 (Boiler 1) helped to reduce dioxin emissions from both boilers.
- There were zero lost-time accidents at the plant in 2009. In June of 2010, the plant will celebrate four years with no loss time accidents.
- The plant was in complete compliance with all of its permits including air quality, water quality and solid waste.
- Maintenance/upgrade activities conducted at the plant in 2009 included boiler tube maintenance, repair and testing in the steam plant and many conveyor system and other upgrades in the RDF processing building.

Manager Hero gave a brief summary of information included in the report, and also had DVDs of the plant tour for interested supervisors. Chair Doyle encouraged the board members to take the tour; to do so they should contact Solid Waste Director Hank Koch to make arrangements. Xcel representatives Herro, Ball and Paitl and Solid Waste Director Koch all responded to questions and comments from the Board.

# RESOLUTION RE: NO. 11-5/10 RE: TO SEEK BIDS FOR AN RCAC (RESIDENTIAL CARE APARTMENT COMPLEX) FOR HILLVIEW HEALTH CARE CENTER / CARROLL HEIGHTS

WHEREAS, on March 8th, 2010 the La Crosse County Board of Supervisors approved the concept of a Residential Care Apartment Complex on the Hillview/Carroll Heights Campus; and, WHEREAS, the County Administrator, Finance Director and Hillview Health Care Center management team presented to the Aging & Long Term Care Committee a procurement/construction process timetable that would enable construction to begin in 2010; and, WHEREAS, the County Administrator, Finance Director and Hillview Health Care Center management team prepared the anticipated cash flow projections and financing options, with consideration to size of the RCAC including the number of apartments and location on the campus. Wipfli accountants reviewed the financial numbers for accuracy along with the La Crosse County Finance Department; and, WHEREAS, a 30 unit RCAC connected to Carroll Heights Apartments will preserve the green space and maintain a beautiful view and setting for all residents and tenants, also allowing a new first impression upon entering our campus; the connection to Carroll Heights will allow tenants to utilize various programs at the new facility; and, WHEREAS, the RFP for design incorporates Green Initiatives. We seek construction to incorporate energy efficiencies into the designs and consult with State of Wisconsin Focus-On-Energy representatives for design recommendations and available rebates on behalf of the county; and, WHEREAS, that the La Crosse County Board approved the selection of PDC Midwest Architects under the guidance of the Aging and Long Term Care Committee as follows: Phase I Pre- Design / Design / Pre-Construction on April 21, 2009. NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board approves the proceeding of, under the guidance of the Aging and Long Term Care Committee as follows: Hillview Health Care Center is authorized to proceed with soliciting bids on construction of a 30-unit RCAC, connecting to Carroll Heights for approximately 3.4 million dollars. BE IT FURTHER RESOLVED, that future approval of the County Board is needed before proceeding with award of bid and construction. FISCAL NOTE: Hillview's 2010 budget includes \$3,496,300 to be funded by borrowing for construction of this facility.

# AGING AND LONG TERM CARE COMMITTEE

Motion by Plesha/Medinger to approve. Discussion ensued. Hillview Administrator Pete Eide, Finance Director Gary Ingvalson and Aging and Long Term Care Committee Chair Roger Plesha responded to questions from the Board. The resolution passed on a roll call vote with 20 ayes, 7 nays - Wehrs, Ebert, Schroeder, Manthei, Ferries, Bina and Feehan, 1 absent - Benrud, 7 excused - Keil, Pfaff, J. Johnson, Billings, Berns, Sebranek and Konkel.

#### FIRST VICE CHAIR T. JOHNSON TOOK THE CHAIR

#### **REVOLVING LOAN FUND SUMMARY / SKIPPER LINER**

Chair Doyle began with information about the structure and purpose of the Revolving Loan Fund, especially for the benefit of the new Board members. He referred to the distributed summary. This fund was established in 1992 with 50% of the proceeds from the sale of the Barlow Street Group Home and the Grandview Building. A Federal Fund was established in 1992 and a State Fund in 1997. The total dollars from all sources was \$1,828,816. These funds revolved back into the Community in the form of loans to various businesses that provided tax base and jobs in the community. He stressed that these were not County property tax dollars, and that the Federal and State funds would have gone to another community if we had not chosen to participate. Because we were able to capitalize these funds through the cooperation of several local businesses (including Skipperliner), we are able to make new loans to businesses that need them as the original recipients pay back the principle and interest. These funds provide "gap financing", participating as a subordinated lender in deals that private lenders were not able to fully fund. Over the years we have made 28 loans which have created 270 jobs. In 2006 the LCEDF (La Crosse County Economic Development Fund) was formed, merging the original Business Fund and the Economic Development Committee. Since then the fund has made strong loans to River Steel, Authenticom, Maid Rite and La Crosse Daycare Centers. The decision to make the recent loan to Skipper Liner was based on their good track record of paying the fund back in full and on time. In the last three years they have paid much in taxes and were deemed worth saving. However, the list of possible upcoming jobs and government contracts they presented to the LCEDF Board apparently did not come to fruition. Now that they have been forced to close their doors we may or may not be paid back, but we will work to get what we can. Lengthy discussion ensued. Doyle, Corporation Counsel Shepherd and La Crosse County Community Development Specialist Brian Fukuda responded to questions from the Board throughout. There is public concern about individuals boats that cannot be removed from storage. Shepherd will discuss this problem with the attorney but there is no answer at this time. The bank has locked the doors and has control over the real estate and assets. Until there is further court action everything is in limbo and unfortunately there are few answers at this time. A motion was received today from the attorneys for the receiver that one lending institution was not going to go along with the 128 filing so it may be switched to a bankruptcy. We are seeking legal advice. The State and the Town of Campbell, who are in worse straits than we are because they will have to repay the State what Skipperliner does not, are jointly hiring a 3<sup>rd</sup> attorney out of Madison who specializes in this sort of thing. The Board will be kept informed as the situation evolves.
