ROLL CALL/CALL TO ORDER

Chair Sharon Hampson called the meeting to order at 5:30 p.m.

OVERVIEW OF SOCIAL MEDIA REQUEST FOR PROPOSAL PROCESS

BOARD EDUCATION

Child & Family Services Review / Program Improvement Plan

The Family & Children's Section participated in a Federal Child and Family Services (CFSR) onsite review in April, 2010. Overall, the state of Wisconsin failed the review. La Crosse County has been invited to participate in the Program Improvement Plan (PIP) Core Team to help draft a plan for the state of Wisconsin. Nancy Pohlman reported they were charged with coming up with 12-15 action steps. They particularly focused on safety and permanence. She stated that while overall La Crosse County does well, there are recommendations that will help them make improvements. She responded to questions from the committee regarding staffing and financial implications, and reported they were careful not to create too much financial burden on counties. The final plan needs to be submitted to the Federal Children's Bureau by September 14, 2010.

Health Department Level III Designation- moved to November.

The item was referred to the November, 2010, meeting.

Complete Streets Initiative

Jack Zabrowski, the bicycle-pedestrian coordinator for the Obesity Prevention program, provided a flier on the Complete Streets workshop he is working on presenting with the Wisconsin Department of Transportation. The workshop will be held on October 5, 2010, at Myrick-Hixon Eco Park in La Crosse. He explained that the Complete Streets concept enables safe access for all users by incorporating public transportation, bike lanes, and pedestrian walkways into street design, thus encouraging increased activity and sustainability. He showed examples of complete streets in other cities where multiple forms of transportation were included. He asked that the HHS Board help to pass a Complete Streets Ordinance by the County Board. Chair Hampson suggested the presentation also be given to the Public Works & Infrastructure Committee, and that the ordinance be presented to County Board by both committees.

Policy, Practice and People of Juvenile Justice

Nicole Milliren and Sharon Krumenauer spoke about a group of eight female adolescents who have been habitual runaways and exhibiting defiant and destructive behaviors. The girls were court-ordered to attend New Vision Wilderness (NVW), an innovative therapeutic program in the Chequamegon National Forest. Seven of the eight successfully completed the NVW program. County staff developed an aftercare plan to enhance the NVW program and reinforce positive behaviors. They chose the Girls Circle curriculum, which is an evidence-based program, for follow-up. They are also utilizing outdoor activities and a "give back" program that encourages the girls to be involved in the community. The girls are also being encouraged to act as mentors if there is another group sent to NVW. Supervisor Billings recommended looking at the Women's Fund for potential funding.

HS Director Process Update

Chair Hampson reported that Jason Witt will be recommended to the County Board as the new La Crosse County Human Services Director, to start on approximately November 1, 2010.

Human Services Complaint and Grievance Procedures

Dean Ruppert stated that Administrative Rules require procedures for clients to be informed of their rights regarding grievances. He said that a blended form for complaints and grievances has been developed to alleviate confusion about which form to use. The form explains the process, and is available at multiple places in the Human Services Department. Clients receive a copy of the Client's Rights and Grievance Procedure on their initial and annual visit. Staff receives annual training on the procedures. He reported that materials have been translated into Spanish and Hmong. Supervisor Billings asked about the impact of grievances on employees, and Ruppert stated a lot of the process involves education along with staff support and monitoring.
