#### **STATUS REPORTS**

<u>Sheriff</u> – The Sheriff's Dept is applying for a technical assistance grant from NIC. This came out of the JTC initiative that they have been working on. They are requesting someone to come in a look at their data and pull out the information that we need to look at recidivism rates and possibly look at other alternatives, even manual spreadsheets, if the data can't be retrieved from their record management system.

<u>Public Defender</u> – Eligibility standards have been changed. They are adding an attorney position since they will be taking on more cases. They will also be hiring someone to fill Attorney Anthony Rios, who is transferring to the Madison office. The two new attorneys are Chris Zachar and Eric Sanford. Their long-time investigator has retired and they will be hiring a replacement for him as well.

<u>Human Services</u> – Human Services is in the process of recruiting for a Supervisor for the Juvenile Justice Unit. Jason Witt handed out some information from Vicki Gunderson regarding 17 year olds in the adult criminal justice system. Vicki participated in some congressional briefings on this topic and through the campaign on Youth Justice and had received this report back which shows where the legislative trends are in various states.

<u>Public Relations & Outreach Committee</u> – They continue to do public speaking with the presentation that they put together. Tomorrow they are speaking to WMMIC and in a few weeks will be presenting to another Rotary group. This year they will look at developing a yearly recognition event, which will recognize people in the community who are doing things to enhance justice in our community. Also they will recognize graduates of treatment courts.

District Attorney – Tim Gruenke reported that the City passed the marijuana ordinance at the city level and he is still finding out information on how this will affect the DA's office and the Sheriff's Dept.

County Board - The County Board is in transition for a new County Board chair, who will be elected tomorrow night. Departments are working on their county budgets.

#### PPAC FOCUS GROUP EXERCISE

Judge Rosborough, from Vernon County was present on behalf of the Public Policy and Planning Committee for the Supreme Court to conduct a focus group to see our perspectives on improving the criminal justice system. Judge Rosborough is the Chair of the Planning Subcommittee of PPPC. Their goal was to go out to other CJMCs in the State and discuss their strengths, weaknesses, opportunities, threats in regards to the criminal justice system. Judge Rosborough then asked the council to discuss the role of the La Crosse County Court System in today's society and how things have changed in the past 5 years and the challenges the court system has faced. He also asked the council what the system will look like in 5 years.
