INFORMATIONAL/MISCELLANEOUS ITEMS

Vicki Burke discussed an article regarding Assembly Bill 286 from *WI News*. This bill would make it harder for convicted felons to get employment. It would allow employers to refuse to hire people convicted of a felony and be able to fire them even if circumstances surrounding the felony have no connection to the job. The CJMC will continue to follow.

AMOS and the La Crosse Community Foundation have been looking at the reception area between the jail and Chemical Health & Justice Sanctions. They have a plan to make this area more inviting, especially for children who come to visit parents. There will be a little picnic table with books and coloring books. There will also be a space for volunteers to be
