The committee agreed that the revision answered their question about the worthiness of a historic site preservation nomination. The public notice will be published in the *La Crosse Tribune* for a public hearing at the May 6, 2011, meeting. **MOTION** by Loomis/Mach to approve the nomination of the Middle Ridge School as a La Crosse County Historic Site. **Motion carried unanimously.** Twinde-Javner excused.

APPROVE APPLICATION FOR NOMINATION OF STRIPED SCHOOL AND SET DATE FOR PUBLIC HEARING

The committee agreed that the nomination application was acceptable. The public notice will be published in the *La Crosse Tribune* for a public hearing at the May 6, 2011, meeting. **MOTION** by Schuppel/Loomis to approve the nomination of the Striped School as a La Crosse County Historic Site. **Motion carried unanimously.** Twinde-Javner excused.

APPROVE 501(c)(3) CRITERIA FOR PRESERVATION GRANT RECIPIENTS

Discussion was held regarding the organizations that are eligible to receive County historic preservation grants and whether a 501(c)(3) designation should be required. Committee consensus was that a 501(c)(3) status lends validity for being granted County funds. **MOTION** by Loomis/Holley to approve leaving the 501(c)(3) requirement language as it is in the grant application. **Motion carried unanimously.** Twinde-Javner excused.
