ROLL CALL/CALL TO ORDER

Chair Vicki Burke called the meeting to order at 2:30 p.m.

APPROVE COMMITTEE MINUTES OF MAY 10, 2011

Chair Burke reported that the Urban Institute will have its last visit on transition from jail to community on June 28-29, 2011.

REPORT ON JAIL CHAPLAINS PROGRAM

Chaplain Skemp was unavailable to speak about the Jail Chaplains program, and the item was referred to the July 12, 2011, agenda.

REPORT ON COST EFFECTIVENESS OF WOMEN'S COMMUNITY BASED PROGRAMMING COMPARED TO JAIL

Jane Klekamp provided the following statistics for the Women's Community Based Program (WCBP):

She reported that the women's jail population has been higher than usual recently. They continue to make the community facility as consumer and community friendly as possible to reduce recidivism. Supervisor Freedland asked about comparisons to other counties' programs, and Klekamp replied that the La Crosse County program is unique. Supervisor Ebert posed several questions regarding cost effectiveness of providing the same programs to the full jail population rather than operating a separate facility. Klekamp spoke about the value of applying skills learned in programming in the community setting. Programs that

are not offered to the full jail population include cognitive behavior programming, health education, work searches, substance abuse treatment, and trauma survivors programs. Klekamp reported that placements can be through sentencing, as an alternative to revocation or posting bond, and in situations where the resident is homeless, jobless, and/or in treatment court.

REQUEST BY RTI DONOR SERVICES TO MEDICAL EXAMINER FOR USE OF MORGUE Steve O'Malley provided information on the request from RTI Donor Services to use the La Crosse County morgue for the purpose of recovering donor tissue. RTI Donor Services is a not-for-profit organization that provides tissue to RTI Biologics, Inc., a for-profit company that uses donor tissue, such as bone, tendons, ligaments, skin, and heart valves for transplant recipients. John Steers introduced Laurie Ripp from RTI Donor Services, who provided background on tissue procurement and use, and the relationship between the notfor-profit and for-profit companies. Discussion was held regarding other companies that provide services, and Ripp reported there are two organ procurement companies, one company that deals only with corneas, and four tissue recovery companies in the state. If RTI Donor Services would contract with La Crosse County, the advantages would include a toxicology report for use by the medical examiner that could prevent conducting an autopsy, and an increased number of tissue donations from being able to secure timely donations and prevent transfer to a funeral home before the family has an opportunity to consider donation. O'Malley said options for the committee could include: accepting the RTI proposal, issuing a Request for Proposal to any interested firms, or some variation of these ideas. MOTION by Freedland/Bilskemper to direct staff to work with Corporation Counsel and bring back a recommendation on options for the committee and County Board to consider whereby tissue can be harvested for the benefit of the community. Motion carried unanimously. Flood excused.
