# CULTURAL COMPETENCY COMMITTEE REPORT: CHRIS CRYE

## SINGLE POINT OF ENTRY PROJECT-STATUS UPDATE: Jason Witt/Coordination of Services Committee

Jason Witt reports that the Single Point of Entry Initiative SOAT is an:

- Integrated model of service delivery;
- Will improve coordination of services;
- Avoids repetition;
- Better captures an immediate holistic view of a client's needs;
- Consolidates reception areas, making better use of the Human Services' physical plan; and
- Result in better integration of after hours systems.

We will be looking at Community Collaboration: how to become more seamless in referrals to the community; could we all use a "single universal referral form".

This committee has talked about Sharing the Resource Databases for example ADRC (Adult Services) uses "Quick Find" database. Youth Services – to be developed, potentially in coordination with Great Rivers 2-1-1.

Cheryl Neubauer, Supervisor of the SOAT (Service Options Assessment Team)

Cheryl Neubauer provided a Power Point presentation regarding the SOAT:

- They will be redesigning the Main Lobby Area.
- There will be 5 staff people for SOAT.
- They will implement a resource database.
- They will do Access/Intake.
- They will provide a kids play area in the lobby.

## FOLLOW-UP TO REBUILDING FOR LEARNING SUMMIT-STATUS UPDATE: JASON WITT

- 1) Collaboration/Communication, agencies and schools, etc.
- 2) Creation of Website more user friendly.
- 3) May have High School students develop the website (they have some kids that have excellent technological skills).
- 4) Working on a "student survey".
- 5) Working on a MOU (Memorandum of Understanding) to have the ability to communicate between schools and agencies, etc.
- 6) Dane County has a program already in place and we are looking at this to avoid reinventing the wheel.

## • HS Director Update: Jason Witt

- Jason Witt reports that our Economic Support Department underwent a big change as of January 3, 2012 they are collaborating with 7 other counties in the Western Region for Economic Assistance.
- We are directing folks for Economic Support to the website or phone number on the handout provided today.
- Family Care Caps we had no wait lists. Other counties had larger wait lists. The Feds are saying "no caps" per waiver for Family Care.
- MA Changes/Waiver Feds partially approved. If people have access to other insurance they will go there.
- Lorie Graff reported that the State turned down \$37 million to develop Wisconsin's Health Care Exchange to provide a more seamless marketplace for accessing health insurance under the President's health care reforms.
- There was discussion today by this group about sending a letter from the Family Policy Board to highlight the broader implications; the higher costs get passed to everyone and to look at the study that has been done. Report how big of an affect/impact it will have on the entire community as a whole. Jason Witt reports that they had a meeting with the hospital partners and they were not in agreement with some of the report's findings.
