This collaboration will allow people to have their physical, mental, and dental needs all met through one system.

INTER-COUNTY AGREEMENTS

Matt Strittmater explained Wisconsin Statute 51.42, which specifies liability for mental health services shall be based on the county of residence, except for emergency services. The county where the emergency occurred is liable for the first 72 hours in emergency situations. More counties are now asking for inter-county agreements be signed, which would put the financial responsibility back on the county of residency. The agreement is on a client-specific need. La Crosse County tries to limit the amount of agreements that are entered into.
