MHRS UNIT PRESENTATION – CLOSER LOOK AT REGIONAL MH-SA DELIVERY SYSTEM PILOT PROJECT

Matt presented a PowerPoint explaining the Mental Health – Substance Abuse Collaborative Pilot that was recently approved. We are one of two pilot programs in the state. The tentative name is Western Region Integrated Care (WRIC). Wisconsin has 72 counties and there is no common thread of services between the counties. One requirement of the RFP was that the pilot must be at least three counties with shared governance, be open to new ideas, and have a public-private mix. The three counties in the pilot are Jackson, Monroe and La Crosse. We will receive a grant of \$200,000 for three years. Updates on the pilot will be presented to the advisory council quarterly.
